#### **GENERAL OVERVIEW**

# **Executive Summary**

Cobb County received funding through the federal governments American Rescue Plan Act (ARPA), enacted by Congress in 2021. This funding was designated for local and state governments to support public health, essential workers, infrastructure improvements, and to mitigate the adverse economic effects of the COVID-19 pandemic. Cobb County has engaged a consultant to manage the distribution and administration of these funds. The consultant conducted meetings with residents, non-profit organizations, and community support groups to gather input on the most effective allocation of the funds. As a result, 261 applications were submitted, and 85 were selected for funding after a thorough vetting process by a committee.

#### **Uses of Funds**

Cobb County, like many jurisdictions across the United States, faced significant challenges while trying to provide enhanced services related to emergency medical facilities, vaccination sites, support for struggling small businesses, and household assistance, all while coping with reduced local revenue. To address these needs, Cobb County developed a comprehensive plan for fund allocation in partnership with a consulting firm. The following expenditure categories have been utilized as part of the American Rescue Plan Act of 2021:

**A. Public Health (EC 1)** – The County is managing forty-one projects and programs related to public health, which include:

- Mental Health Services
- Other COVID-19 Public Health Expenses
- Other Public Health Services
- Prevention in Congregate Settings (such as nursing homes, high-density workplaces, schools, and childcare facilities)
- Substance Use Services

Funds have been allocated through the following county departments and services to address these public health impacts:

- Property Management Department
- Department of Health and Human Services (Cobb Douglas Public Health)
- Medical Examiner's Office
- Department of Public Safety
- Countywide Infrastructure
- Support Services

## 1. Prevention in Congregate Settings:

The County has allocated funds to renovate several courtrooms to implement COVID-19 safety measures while maintaining court operations. The pandemic significantly impacted court functions, causing delays, cancellations, and stays of many constitutionally and statutorily required proceedings. To address these challenges, the court system has adopted comprehensive health protocols. While visible precautions include PPE, mandatory masks, and plexiglass barriers, social distancing remains a critical and complex issue. Courts must meet legal requirements to handle cases promptly, sometimes within state-mandated timelines. For criminal cases, the U.S. Constitution's confrontation clause necessitates in-person witness interactions, complicating social distancing efforts.

To resolve these issues, the County is enhancing courtroom capacity to comply with social distancing guidelines. Additionally, the District Attorney's Office is improving physical space and structural capacity to support operational needs while adhering to health protocols. Cobb Senior Services will also use funds to implement safety measures in their facilities, including expanding wellness programs, increasing transportation services, and installing air purifying filters. #### 2. Mental Health Services:

Funds allocated for mental health services are aimed at supporting low-income and minority communities. The County is offering various wellness programs that include peer support, medication management, psychological assessments, and behavioral health counseling. Specialized mental health and grief counseling are available for individuals who lost family members during the pandemic or who have experienced domestic violence, with some services provided at no cost.

Additional support includes medical supply kits, health insurance assistance, and other resources for individuals with or at risk of HIV/AIDS. To enhance accessibility, mental health resources are being integrated into diverse settings, such as after-school and summer youth programs, and tools are being implemented to monitor referral outcomes for veterans seeking mental health support. The aim is to ensure comprehensive tracking and addressing of veteran needs from start to finish.

Mental health training is being provided to first responders and other front-line workers, and mental health clinicians and case workers are being embedded within 911 call centers and coresponder units. These units are placed in areas with high mental health case prevalence to ensure prompt access by law enforcement, first responders, and the judicial system. ## 3. Other COVID-19 Public Health Expenses:

Funds designated for other COVID-19 public health expenses are used to support the Medical Examiner's Office by ensuring they have adequate sanitation supplies and personal protective gear. These resources are crucial for maintaining hygiene and safety in their operations. Additionally, the funds are being allocated to expand storage space and to enhance the County's stockpile with necessary sanitation and personal protective equipment. #### 4. Other Public Health Services:

Funds allocated for Other Public Health Services are supporting several key initiatives:

- Emergency Services: Cobb County Fire & Emergency Services are acquiring transport rescue vehicles to improve the efficiency of emergency responses and reduce delays at hospitals. Additionally, cardiac monitors and manual chest compression devices are being procured for first responders.
- **Vision Care**: Mobile vision clinics and services within Marietta City Schools are providing free eye exams and glasses to underserved communities.
- Maternal and Infant Health: The Cobb County Board of Health, in partnership with a local hospital system, is offering screening, assessment, and referral services for highrisk, underserved pregnant women in Cobb County.
- Public Health Outreach: The Cobb County Board of Health will also expand its public health outreach by providing medical screenings, testing, vaccinations for various diseases, and promoting prevention through mobile clinics.

#### **5. Substance Use Services:**

Funding for Substance Use Services is being used to support a range of critical initiatives:

- **Sober Housing**: Temporary sober housing assistance is provided to individuals in recovery.
- **Treatment Services**: Medication-assisted treatment (MAT) and residential treatment programs for substance abuse disorders are available. These services include in-service mental health support for individuals within the criminal justice system struggling with substance use issues.
- Opioid Addiction: Efforts to combat opioid addiction include expanding access to harm reduction supplies and increasing the number of medical providers offering opioid medication-assisted therapy.
- **Residential Treatment**: Evidence-based residential treatment for substance use disorders (SUD) is being provided for homeless men, with efforts to enhance capacity at residential treatment facilities across Cobb County.

**B. Negative Economic Impacts (EC 2)** – The County is overseeing fifty-one projects and programs aimed at addressing negative economic impacts. These initiatives include:

#### 1. Educational Disparities: Academic, Social, and Emotional Services

This category is being addressed by equipping Cobb County Schools with school-based site coordinators who offer both academic and non-academic support to enhance student success. Additionally, a program is introducing music-oriented activities for underserved youth, including transportation services and efforts to close gaps in childcare access. Early literacy is being promoted through a program that provides developmentally, culturally, and linguistically appropriate books during pediatric visits. A trained medical provider offers families a book to take home for their child and discusses the benefits of reading aloud together. # 2. Aid to Tourism, Travel, or Hospitality:

Cobb Travel and Tourism, in collaboration with the Cobb Chamber and Select Cobb, manages a grant program designed to support areas of Cobb's hospitality and tourism sectors that are struggling with workforce issues. This includes art organizations, live entertainment venues, tourist attractions, and craft beverage producers. # 3. Household Assistance, Food Programs:

During the early stages of the COVID-19 pandemic, funding was provided to a corporation that delivered essential food assistance to Cobb citizens, alleviating some of the economic and emotional burden on families in need. The funds were used to purchase food vouchers/cards, food boxes, supplies for food banks or pantries, and support food distribution efforts. Food insecurity is being tackled through various projects aimed at increasing capacity for traditional and choice food pantries, expanding their supply of produce and shelf-stable foods, supporting transportation, and covering related payroll expenses. These projects address food insecurity among homeless populations, low-income households, low-income minority households, and individuals affected by terminal illness. # 4. Assistance to Unemployed and Underemployed Workers:

Support is provided through programs offering free adult and youth job training, skills development, job placement assistance, and various workforce development activities. These initiatives are specifically aimed at individuals with disabilities and those in Cobb County's most underserved and economically disadvantaged communities. Programs include paid summer and year-round employment opportunities for Cobb County youth, which help participants gain work experience while assisting employers with talent needs. Additionally, a partnership with a local healthcare network will offer certification programs for aspiring nursing assistants. The programs also support business owners and underemployed individuals with income strategy planning, mentoring, leadership development, civic engagement, workforce development, and life skills training. These efforts are designed to unlock youth potential and equip them with the tools to succeed in their homes, schools, workplaces, and communities. GED counselors and job readiness coaches will be available to assist underemployed and unemployed individuals, as well as low-income high school students. The ultimate goal is to enhance employment opportunities and enable participants to secure jobs that provide sufficient income to meet their basic needs. #### 5. Internet Access Assistance:

Support is being provided to a veteran's non-profit organization to ensure broadband access for those who cannot obtain it independently, thereby promoting digital equity. The organization will identify community groups and collaborate with them to offer 60–90-minute Digital Literacy workshops, using curriculum developed by AT&T in partnership with the Public Library Association (PLA). Topics covered in the workshops include Internet Basics, Email Basics, Cyber Security Basics, Computer Basics, Mobile Device Basics, and Video Conferencing. Additionally, the program will provide households with digital literacy resources. # 6. Household Assistance: Rent, Mortgage, and Utility Aid:

Financial assistance is being provided through programs designed to support underserved, low-income, terminally ill, and minority communities facing housing insecurity. These programs offer temporary and limited financial aid to prevent eviction for low-income households, both with and without dependent children. They also support organizations that help homeless individuals and families secure stable housing and provide aid to financially struggling food service workers. Part of the funding will be allocated to develop a virtual platform that streamlines the application process, increasing efficiency and ensuring compliance. The funding will cover direct assistance such as application fees, security deposits, renter's insurance, rent, and utility payments, as well as payroll, supplies, materials, and professional services including administrative support. A vendor will manage and implement Cobb County's program objectives, which include: 1) offering rental, utility, and/or security deposit assistance to Cobb County residents, and 2) establishing a network of qualified specialists to create seamless access and entry points. # 7. Loans or Grants to Mitigate Financial Hardship:

Funding is being provided to SelectCobb to help childcare learning centers and family childcare homes address their workforce challenges. For more information about Loans or Grants to Mitigate Financial Hardship, please refer to the project inventory listing.

# 8. Long-Term Housing Security:

Services for unhoused individuals are being provided to organizations with existing shelter programs that support homeless families. The funds will be used to expand capacity, allowing these programs to assist more families. Additionally, some programs collaborate with Open Doors to help locate and secure lease agreements for homeless residents participating in housing initiatives supported by the Marietta/Cobb Continuum of Care agencies and stakeholders.

To further enhance long-term housing security, ARPA support will fund the development of 14 single-family affordable homes for Cobb families with incomes at or below 65% AMI. This initiative will involve acquiring, rehabilitating, and constructing scattered-site homes, thereby increasing the county's supply of affordable for-sale single-family homes. Priority for these homes will be given to county employees, veterans, teachers, and other essential workers. # 9. In promotion of Strong Healthy Communities: Demolition and Rehabilitation of Properties:

Several projects have been funded to enhance healthcare capacity by expanding facilities. One healthcare center will increase its space by 5,000 square feet, adding 11 exam rooms, a licensed pharmacy, and an expanded patient waiting area. Another project will construct a new building to improve access to public health services for South Cobb residents, including adult and pediatric primary care, mental health services, HIV diagnosis and treatment, telehealth, and connections to other community resources. Additionally, major¹ and minor home repairs will be provided at no cost to older adults, veterans, and low-income homeowners following a home inspection. Eligibility and project selection will be managed by MOWA. # 10. In Promotion of Strong Healthy Communities: Neighborhood Features that Promote Health and Safety

A project has been funded to develop an 8-acre site featuring a community plaza, outdoor restrooms, and an inclusive playground. The site will offer free visits for students and provide opportunities for all demographics to engage in interactive education through Family Fun Safety Days, Camp Puzzle Days (for the autistic community), and educational events for seniors and adults. # 11. Technical Assistance, Counseling, or Business Planning

The community is being offered opportunities through programs aimed at economic development and designed to support individuals negatively impacted by the COVID-19 pandemic. These programs include proactive youth-focused mentoring, life skills training, workforce readiness, and leadership development services. Additionally, efforts are being made to enhance accessibility by creating workforce access points, which aim to strengthen and expand the county's talent pool. This expansion improves job seekers' ability to access employment, education, training, and support services, thereby increasing their chances of success in the labor market.

A Business Boot Camp has also been introduced to help minority small business owners enhance their processes and sustainability through improved business planning, marketing, sales, capital acquisition, hiring, and onboarding. Furthermore, one-on-one training is available for micro/solo business owners who have experienced a reduction in income, closed their businesses, or are seeking new employment opportunities. #### 12. Household Assistance: Survivors Benefits

The program will offer a fully furnished transitional home to numerous families, providing the care and support necessary to help them successfully embark on a new, productive beginning. #### 13. Economic Impact Assistance: Other

This initiative aids economic recovery by focusing on the business sector and workforce opportunities. It supports workforce development, small and minority-owned businesses, employee retention, and the hospitality and tourism industries. Additionally, Legal Aid's "Lawyer in the Library" project offers free general legal information and personalized legal advice on issues such as housing stability, income maintenance, access to public benefits, family law, and consumer matters.

# C. Public Health - Negative Economic Impact: Public Sector Capacity (EC 3)

The county is undertaking nine projects aimed at addressing the needs of disproportionately impacted communities. These projects focus on:

- Public Sector Workforce: Payroll and Benefits for Public Health, Public Safety, or Human Services
- Public Sector Capacity: Administrative Needs
- Public Sector Workforce: Other

These initiatives are designed to enhance the capacity and effectiveness of public sector services in response to economic impacts.

# 1. Public Sector Capacity-Administrative Needs

Public Sector Capacity-Administrative Needs are currently being tackled through a project aimed at reducing pandemic-related backlog in the judicial system. This backlog arose due to the implementation of social distancing guidelines to safeguard public health. The project aims to restore and strengthen public sector capacity while facilitating mediation. It plays a crucial role in bridging the gap between tenants facing eviction and landlords seeking assistance. # 2. Public Sector Workforce: Payroll and Benefits for Public Health, Public Safety, or Human Services

Public Sector Workforce initiatives are addressing various challenges through strategic funding reallocations. These efforts include offsetting personnel costs for staff attorneys and investigators across departments, responding to retention issues exacerbated by significant pay increases in neighboring counties. Programs are also focused on recruiting and retaining certified/sworn personnel within Cobb County Public Safety and the Sheriff's Office, addressing recent employee losses to other jurisdictions. Furthermore, support is being provided to Cobb County Courts to manage backlog by expanding court personnel, consolidating lost revenue, and acquiring necessary equipment for court proceedings.

Additional measures include the payment of half of all juror fees over a two-year period, legal clinics conducted at the courthouse law library offering public legal consultations, and informational sessions covering family law, income maintenance, health, probate, housing, and consumer matters. Operational costs for a non-profit organization engaged in significant community food supply and distribution services will also be covered.

#### 3. Other Public Sector Workforce Projects

The project includes HVAC upgrades aimed at enhancing indoor air quality based on scientific standards and implementing measures to mitigate COVID-19 transmission. These upgrades will focus on buildings with high foot traffic located in underserved communities, including public safety, government, and judicial system facilities serving residents in these areas. Additionally, the initiative ensures that 100% of respiratory-related deaths in Cobb County are accurately diagnosed, recorded in death records, and reported to public health authorities.

The final rule supports efforts to mitigate the spread of infectious diseases through comprehensive testing, reporting, and ongoing monitoring. For further details on Public Sector Workforce initiatives under "Other," please refer to the project inventory listing.

#### D. Infrastructure projects in the county encompass four key areas:

- Clean Water: Storm Water projects focus on managing stormwater runoff effectively to protect water quality and prevent flooding.
- Other: Sewer Infrastructure Projects involve upgrading and maintaining sewer systems to ensure efficient wastewater management and environmental compliance.
- **Broadband: Other Projects** aim to enhance broadband infrastructure across the county, improving internet access and connectivity for residents and businesses.
- Clean Water: Other Sewer Infrastructure initiatives include various efforts to further develop and maintain sewer infrastructure, ensuring continued environmental sustainability and public health protection.

The County has allocated funds through the Department of Public Safety and Support Services to address various Infrastructure projects:

# 1. Clean Water: Stormwater Projects

The projects involving the repair and replacement of failed stormwater piping are detailed in the project inventory listing. Please consult that document for comprehensive information regarding these specific Clean Water: Stormwater initiatives.

# 2. Clean Water: Other Sewer Infrastructure Projects

This project involves the rehabilitation of seven wastewater pump stations and one drinking water pump station. This effort will involve replacing three pumps, installing new electrical buildings at two stations, replacing standby generators and automated transfer switches, and constructing new concrete pads and fences. # 3. Broadband: Other Projects

This project will upgrade bandwidth connectivity at community and recreation centers and enhance infrastructure at the county's data center to increase capacity. This upgrade will expand outdoor Wi-Fi coverage for nine Cobb County community and recreation centers. For more information about Broadband: Other projects, refer to the project inventory listing.

#### 4. Other Sewer Infrastructure Projects

This project aims to assist low-income Cobb homeowners by funding repairs for failing septic tanks and providing pumping services for those on proper septic systems. For further details on Other Sewer Infrastructure projects, please see the project inventory listing.

**E. Surface Transportation-** The county has allocated funds to its Department of Transportation for six projects aimed at bridge and road repairs, improvements, and rehabilitation. These

projects include both those receiving funding from the Department of Transportation (DOT) and those funded through other sources.

- 1. **Projects receiving funding from the DOT** include the Powers Ferry Bridge Rehabilitation project, which focuses on repairing and rehabilitating the bridge, and the Cumberland Transfer project, which aims to expand and relocate the transfer center.
- 2. Projects not receiving funding from the DOT include the following:
  - **a.120-Factory Shoals Rd Multimodal Study** Focused on enhancing safety and connectivity through multimodal improvements.
  - **b. Allatoona Creek Greenway Trail -** Aims to provide alternative transportation connections between schools, parks, and cultural amenities.
  - c. Kennesaw State/Town Center Transit-Oriented Development Study Addresses transit solutions to meet mobility needs.
  - **d. East-West Connector Corridor Improvements -** Designed to improve vehicular and pedestrian safety as well as increase road capacity.

- **F. Administrative and Other-** There are two administrative projects as follows:
- **1. ARPA Program Administration:** This project covers the costs associated with managing the ARPA (American Rescue Plan Act) program. This could include expenses related to staffing, operational support, compliance, and reporting.
- **2. County Record Retention and Storage**: This project addresses the needs for managing and storing county records. It likely involves expenses related to physical or digital storage solutions, organization, and possibly updating or maintaining records systems.

# Promoting equitable outcomes

An online portal was created for organizations to apply for grants distributed across five key areas: community health, support services, economic development, county infrastructure, and public safety. Applications were evaluated on a rolling basis and needed to address the needs of communities affected or disproportionately impacted by the COVID-19 pandemic. According to the January 20, 2021, Executive Order on Advancing Racial Equity and Support for Underserved Communities Through the Federal Government, "equity" is defined as the consistent and systematic fair, just, and impartial treatment of all individuals, including those from underserved communities who have historically been denied such treatment.

This includes Black, Latino, Indigenous and Native American individuals, Asian Americans, Pacific Islanders, other people of color, religious minorities, LGBTQ+ individuals, persons with disabilities, residents of rural areas, and those affected by persistent poverty or inequality.

# A. Observation Based on Reported Information

- Impact on Underserved Communities: Out of 87 projects, 67 (77%) reported affecting at least one of the 11 underserved communities specified in the Executive Order for Q1 2024. The remaining 20 projects did not specify which communities they served.
- **Specific Impact**: Six projects explicitly reported impacting the 11 underserved communities.
- **Broad Impact**: Thirty-one projects reported benefiting 5 or more of the 11 underserved communities.
- **Other Populations**: Projects categorized as 'Other' commonly serve populations such as those who are food insecure and individuals who are biracial or multiracial.
- Qualified Census Tracts (QCTs): Forty-five of the 89 active projects are being
  conducted or are planned within one or more qualified census tracts (QCTs), which are
  indicative of areas with heightened needs. As more projects are implemented, additional
  data will be available to assess the ARPA investment in QCTs, the number of individuals
  served, and the overall impact.

# **Labor Practices**

#### **Procurement Services Overview**

Procurement Services is responsible for purchasing and acquiring materials, supplies, equipment, and services for all County departments.

#### Use of Evidence

A residential treatment program by The Extension, Inc. provides homeless addicted men evidence-based residential SUD treatment.

Hispanic or Latino children in Cobb County will receive evidence-based mental health services, free of charge, in their native language to ensure equitable access to quality life, education, and future employment opportunities. Additionally, their caregivers will receive support services to aid their children both now and in the future. This project aims to assist Latino families impacted by COVID-19 by employing staff specifically to serve this population in their primary language.

# **Performance Report**

#### **Current Project Status and Risk Assessment**

- On-Time Performance: The percentage of projects considered on-time has been steadily increasing. As of the most recent data, 86% of projects are reported to be on schedule, and 91% are on track financially to meet the 2026 expenditure deadline.
- **Project Completion**: KPI survey data shows significant progress since Q4 2023. Fortyone projects (47%) have completed at least 25% of their activities, and five projects (6%) are fully completed.
- **Spending Status**: Thirteen projects (15%) reported spending 0% of their ARPA award since funds were obligated. This collaboration has been serving the community for over 25 years, and from January 2022 through June 2022 alone, it distributed 22,961 lbs. of food to 324 families (comprising 922 individuals).
