Eligibility: Artists may submit a maximum of two (2) original 2D artworks for consideration. 2D Artworks larger than 18inx24in will not be accepted. **2D Artwork must have a wire hanging mechanism on a frame (no sawtooth hangers).** All accepted artworks must include a title, the artist's name, price (or listed as not for sale). A short description is optional and can

include a blurb about the artwork and social media handles. Sewell Mill Cultural Center staff will make the final determination of display arrangement and reserves the right to not display all pieces submitted. All works must be original and made by the persons submitting. Work created using Artificial Intelligence (A.I.) will not be accepted. Acceptable works include but not limited to: photography, drawing, mixed media, paintings, etc. Art work previously displayed in the past 12 months at the Sewell Mill Cultural Center will not be accepted.

Delivery: Once an artist's work has been accepted, they will have September 19th-20th, 2025 to drop off their work. Late submissions will not be accepted. **Artists will be responsible for hand-delivery of work to (and picked-up from) the Sewell Mill Cultural Center.** The artist is responsible for any insurance on his/her work. No artwork is to be shipped directly to the Sewell Mill Cultural Center.

Art Pick up: The art can be picked up after the exhibit is over. Pick date is November 3rd, 2025. Gallery hours are Monday-Saturday 10am-5pm. Please call 770-509-4989 for extended weekend and evening hours.

Agreement: Submission of works to this exhibition constitutes agreement on the part of the artist to all terms and conditions of this entire prospectus, which includes, but is not limited to, the right of the Sewell Mill Cultural Center to use entries for publicity. Unless otherwise specified to the Sewell Mill Cultural Center staff in writing by the artist, the artwork may be used for the Sewell Mill Cultural Center publicity and archives. By submitting, the artist agrees that they own the artwork and have sole permission to submit. **The artwork for this exhibit will be on display in the Art Classroom Hallway.**

Liability: Neither the Sewell Mill Library & Cultural Center nor Cobb County PARKS (nor their employees, agents, officers) will be held responsible for lost or damaged artworks. The artist is responsible for any insurance on his/her work during the exhibition. While utmost care is given to all entries, Sewell Mill Cultural Center and Cobb County PARKS do not assume any liability for damage or loss, before, during or after the exhibition. Artist is responsible for insurance.

Sales: Cobb PARKS does not process or facilitate direct sales transactions for exhibited artwork. However, for works designated with a price, Cobb PARKS will facilitate communication between interested patrons and the artist for direct purchase inquiries.
