LEGAL DESCRIPTION

A SUBDIVISION OF LAND IN SECTION 18, TOWNSHIP 32 SOUTH, RANGE 40 EAST, INDIAN RIVER SHORES, INDIAN RIVER COUNTY, FLORIDA MORE PARTICULARLY DESCRIBED AS FOLLOWS:

BEGIN AT THE SOUTHWEST CORNER OF TRACT 'F', JOHN'S ISLAND PLAT 40 AS RECORDED IN PLAT BOOK 12, PAGE 10, PUBLIC RECORDS OF INDIAN RIVER COUNTY, FLORIDA; THENCE, N 11°00'29"W, ALONG THE WEST LINE OF SAID TRACT 'F', 163.17 FEET; THENCE, N 53°14'37"E, ALONG THE NORTH LINE OF SAID TRACT 'F', 107.14 FEET TO THE SOUTH WEST CORNER OF TRACT 'G', JOHN'S ISLAND PLAT 33 AS RECORDED IN PLAT BOOK 13, PAGE 72, PUBLIC RECORDS OF INDIAN RIVER COUNTY, FLORIDA, SAID POINT ALSO BEING THE POINT OF CURVATURE OF A NON-TANGENT CIRCULAR CURVE HAVING A RADIUS OF 480.00 FEET; SAID POINT BEARS S 53°14'37"W FROM THE RADIUS POINT OF SAID CURVE; THENCE, NORTHWESTERLY, THROUGH A CENTRAL ANGLE OF 16°22'33" FOR AN ARC DISTANCE OF 137.19 FEET TO A POINT ON THE SOUTH LINE OF LOT 1 OF SAID JOHN'S ISLAND PLAT 33; THENCE, ALONG THE SOUTHERLY LINE OF SAID LOT 1, S 69°37'10"W, 35.47 FEET; AND N 70°15'47"W, 190.61 FEET TO THE SOUTHEAST CORNER OF TRACT 'D' OF SAID JOHN'S ISLAND PLAT 33; THENCE, ALONG THE SOUTH LINE OF SAID TRACT 'D', S 89°14'17"W, 369.21 FEET; THENCE, S 18°42'51"W, 121.21 FEET TO A POINT ON THE NORTH RIGHT-OF-WAY LINE OF STINGAREE POINT AS RECORDED IN THE ABOVE REFERENCED JOHN'S ISLAND PLAT 40; SAID POINT ALSO BEING THE POINT OF CURVATURE OF A NON-TANGENT CIRCULAR CURVE HAVING A RADIUS OF 106.91 FEET; SAID POINT BEARS N 19°53'24"E FROM THE RADIUS POINT OF SAID CURVE; THENCE, ALONG SAID NORTH RIGHT-OF-WAY LINE, SOUTHEASTERLY, THROUGH A CENTRAL ANGLE OF 27°35'02" FOR AN ARC DISTANCE OF 51.47 FEET TO THE POINT OF TANGENCY; THENCE, S 42°10'34"E, 171.49 FEET TO THE POINT OF CURVATURE OF A CIRCULAR CURVE CONCAVE TO THE SOUTHWEST, HAVING A RADIUS OF 325.00 FEET; THENCE, SOUTHEASTERLY, THROUGH A CENTRAL ANGLE OF 11°37'29" FOR AN ARC DISTANCE OF 65.95 FEET TO THE POINT OF REVERSE CURVATURE OF A CIRCULAR CURVE HAVING A RADIUS OF 175.00 FEET; THENCE, SOUTHEASTERLY THROUGH A CENTRAL ANGLE OF 30°14'53" FOR AN ARC DISTANCE OF 92.39 FEET TO THE POINT OF TANGENCY; THENCE, S 61°08'53"E, 126.39 FEET TO THE POINT OF CURVATURE OF A CIRCULAR CURVE CONCAVE TO THE NORTHEAST HAVING A RADIUS OF 200.00 FEET; THENCE, EASTERLY, THROUGH A CENTRAL ANGLE OF 6°15'59" FOR AN ARC DISTANCE OF 238.29 FEET TO THE POINT OF COMPOUND CURVATURE OF A CIRCULAR CURVE HAVING A RADIUS OF 100.00 FEET; THENCE, NORTHEASTERLY, THROUGH A CENTRAL ANGLE OF 26°27'36" FOR AN ARC DISTANCE OF 46.18 FEET TO THE POINT OF BEGINNING.

SAID PARCEL CONTAINS 5.00 ACRES OF LAND MORE OR LESS AND LIES WHOLLY IN INDIAN RIVER COUNTY, FLORIDA.

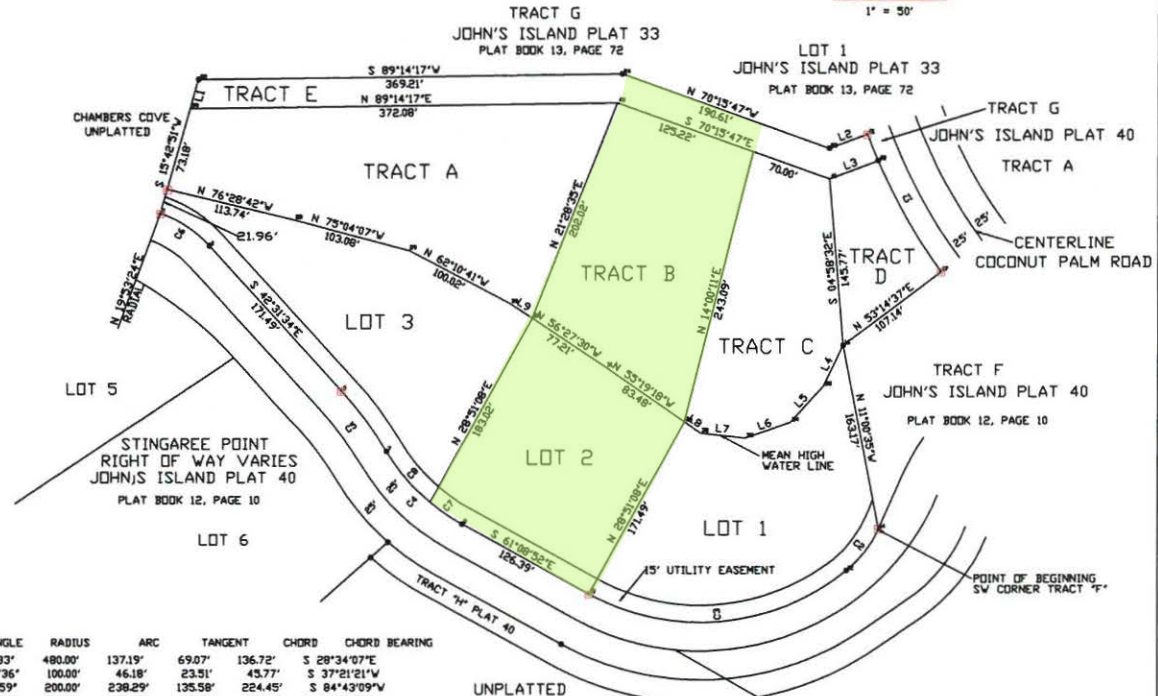
