

END-USER LICENSE AGREEMENT FOR Skanect.

IMPORTANT PLEASE READ THE TERMS AND CONDITIONS OF THIS LICENSE AGREEMENT CAREFULLY BEFORE CONTINUING WITH THIS PROGRAM INSTALL.

Occipital Inc. End-User License Agreement ("EULA") is a legal agreement between you (either an individual or a single entity) and Occipital Inc. for the Occipital Inc. software product(s) identified above which may include associated software components, media, printed materials, and "online" or electronic documentation ("Skanect").

By installing, copying, or otherwise using the Skanect product, you agree to be bound by the terms of this EULA. This license agreement represents the entire agreement concerning the program between you and Occipital Inc., (referred to as "licenser"), and it supersedes any prior proposal, representation, or understanding between the parties. If you do not agree to the terms of this EULA, do not install or use the Skanect product.

The Skanect product is protected by copyright laws and international copyright treaties, as well as other intellectual property laws and treaties. The Skanect product is licensed, not sold.

1. GRANT OF LICENSE.

The Skanect product is licensed as follows:

(a) Installation and Use.

Occipital Inc. grants you the right to install and use copies of the Skanect product on your computer running a validly licensed copy of the operating system for which the Skanect product was designed [e.g., Windows XP, Windows 7, Windows 8, MacOSX].

(b) Backup Copies.

You may also make copies of the Skanect product as may be necessary for backup and archival purposes.

(c) Commercial use.

The free version of the Skanect product must not be used for commercial purposes or to generate revenue directly or indirectly.

2. DESCRIPTION OF OTHER RIGHTS AND LIMITATIONS.

(a) Maintenance of Copyright Notices.

You must not remove or alter any copyright notices on any and all copies of the Skanect product.

(b) Distribution.

You may not distribute registered copies of the Skanect product to third parties. Evaluation versions available for download from

Occipital Inc's websites may be freely distributed.

(c) Prohibition on Reverse Engineering, Decompilation, and Disassembly.

You may not reverse engineer, decompile, or disassemble the Skanect product, except and only to the extent that such activity is expressly permitted by applicable law notwithstanding this limitation.

(d) Rental.

You may not rent, lease, or lend the Skanect product.

(e) Support Services.

Occipital Inc. may provide you with support services related to the Skanect product ("Support Services"). Any supplemental software code provided to you as part of the Support Services shall be considered part of the Skanect product and subject to the terms and conditions of this EULA.

(f) Compliance with Applicable Laws.

You must comply with all applicable laws regarding use of the Skanect product.

3. TERMINATION

Without prejudice to any other rights, Occipital Inc. may terminate this EULA if you fail to comply with the terms and conditions of this EULA. In such event, you must destroy all copies of the Skanect product in your possession.

This EULA grants you no rights to use such content. All rights not expressly granted are reserved by Occipital Inc.
