OFFICIAL RULES

NO PURCHASE NECESSARY TO WIN and purchase does not increase your chances of winning. Void where prohibited. Contest open only to legal residents of Georgia, North Carolina, South Carolina, Virginia, Maryland, Delaware and the District of Columbia who are 18 years of age or older as of July 28, 2020. Contest ends on July 28, 2020.

Electronic Entry: Any time between July 1 and July 28, 2020, you will be entered when you successfully complete upload and share an image of a final pickling recipe with recipe steps in caption to either Wyng page or Instagram with #htpicklincontest. Valid email address, VIC Card number and VIC household information required to enter contest.

A free VIC Card can be obtained upon application at any Harris Teeter store. VIC Cards that are stolen, fraudulent, tampered with or otherwise altered are not eligible for use in the Contest.
