

MIRANDA LAMBERT MUTTNATION FOUNDATION SWEEPSTAKES

Official Rules

- 1. NO PURCHASE, SURVEY OR SALES PRESENTATION NECESSARY TO ENTER OR WIN THE MIRANDA LAMBERT MUTTNATION FOUNDATION SWEEPSTAKES (THE “SWEEPSTAKES”).** A purchase, survey or agreeing to a sales presentation will not improve your chances of winning. OPEN ONLY TO TRACTOR SUPPLY COMPANY NEIGHBOR’S CLUB (THE “NEIGHBOR’S CLUB”) MEMBERS WHO ARE LEGAL RESIDENTS OF, AND RESIDING IN, THE CONTIGUOUS 48 UNITED STATES, HAWAII, THE DISTRICT OF COLUMBIA, AND WHO ARE 21 YEARS OF AGE OR OLDER AS OF DATE OF ENTRY. Void in Alaska, Puerto Rico and where restricted or prohibited by law.

Sweepstakes begins August 5, 2024, at 12:00 a.m. Eastern Time (“ET”) and ends September 1, 2024, at 11:59:59 p.m. ET (“Sweepstakes Period”). The Sweepstakes is sponsored by Tractor Supply Company (“Sponsor”). By entering the Sweepstakes, you accept and agree to be bound by these Official Rules.

- 2. ELIGIBILITY:** Employees of Sponsor, Mercury Promotion & Fulfillment (“Administrator”), Miranda Lambert and her partners, any Miranda Lambert participating sponsor, MuttNation Foundation (“MuttNation”), and their respective parents, subsidiaries, and affiliated companies, divisions, suppliers and advertising and promotion agencies, and the immediate family members (spouse, parent, child, sibling and their respective spouses, regardless of where they reside) and household members, whether or not related (the “Sweepstakes Entities”), of each such employee are not eligible to enter or to win the Sweepstakes.

- 3. HOW TO ENTER:** An eligible entrant (“Entrant”) may enter by visiting <https://www.tractorsupply.com/tsc/cms/social-contest-online> (the “Website”), completing and submitting the online entry form. To complete the online entry form, the Entrant may be required to enter his/her complete first name, last name, street address (no P.O. Box), city, state, ZIP Code, valid e-mail address and mobile phone number associated with their Neighbor’s Club account. All Entrants must check the box agreeing to the Sponsor’s privacy policy, the Neighbor’s Club Terms and Conditions and these Official Rules. An Entrant who is not a Neighbor’s Club member can only enter this Sweepstakes by becoming a Neighbor’s Club member during the Sweepstakes Period. An Entrant can become a member of the Neighbor’s Club by logging on to <https://www.tractorsupply.com/neighborsclub> and following the directions to register for the Neighbor’s Club. There is no cost to becoming a Neighbor’s Club member. Incorrect and incomplete entries are void. All entries must be received prior to the end of the Sweepstakes Period to be valid.

Limit one (1) entry per person during the entire Sweepstakes Period. No other form of entry is permitted.

Multiple participants are not permitted to share the same email address. Any attempt by an Entrant to obtain more than one (1) entry throughout the Sweepstakes Period by using multiple/different email addresses, identities, registrations or logins, or any other methods may void your entries and you may be disqualified from the Sweepstakes. Any use of robotic, repetitive, automatic,

programmed, or similar entry methods or agents (including, but not limited to, sweepstakes entry services) will void all entries by you. In the event of a dispute as to any entry, the authorized account holder of the email address used to enter will be deemed to be the Entrant. The "authorized account holder" is the natural person assigned an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. A potential winner may be required to show proof of being the authorized account holder.

In addition, an Entrant must be a Neighbor's Club member when the Grand Prize is awarded. Each Entrant is responsible for having updated and correct contact information in his/her Neighbor's Club account registration.

- 4. DRAWING AND ODDS OF WINNING:** Two (2) potential Grand Prize winners will be determined in a random drawing by the Administrator on or about September 3, 2024, from among all eligible entries received during the Sweepstakes Period.

The odds of winning a Grand Prize depend upon the number of eligible entries received during the Sweepstakes Period.

Each potential winner will be notified by email or telephone (at Sponsor's sole discretion), on or about September 3, 2024, at the contact information indicated in the Entrant's information provided at registration as set forth in Rule 3. Each potential Grand Prize winner will be required to execute an Affidavit of Eligibility and Liability and Publicity Release (except where prohibited), to be returned by the date as set forth in the notification email or the Grand Prize will be forfeited, and, at Sponsor's discretion, an alternate winner will be selected from all remaining eligible entries. Return of the Grand Prize notification as undeliverable or noncompliant with these Official Rules may result in the Grand Prize being forfeited and, at Sponsor's discretion, an alternate winner will be selected from all remaining eligible entries. A potential winner must comply with all terms and conditions set forth in these Official Rules and winning is contingent upon fulfilling all such requirements.

The two (2) Grand Prizes will be the only prizes awarded in this Sweepstakes.

- 5. GRAND PRIZE (2):** Each Grand Prize winner will receive a trip for up to two (2) people (the confirmed Grand Prize winner and one [1] guest) to Nashville, Tennessee to see Miranda Lambert in concert (the "Grand Prize") on October 5, 2024. Each Grand Prize will consist of all of the following elements:

- (i) round-trip coach class airfare for the Grand Prize winner and his/her guest to Nashville International Airport from the major U.S. airport nearest Grand Prize winner's residence (as determined by Sponsor) departing on October 4, 2024, and returning on October 6, 2024;
- (ii) three (3) days and two (2) nights hotel accommodations, one (1) standard room (double occupancy) as determined by Sponsor;
- (iii) ground transportation to and from the airport to the hotel in Nashville;
- (iv) Concert & VIP Meet-Greet Experience, which is scheduled to include the following items subject to availability: (a) a pink carpet entrance for Grand Prize winner and guest with a photo opportunity in front of the VIP backdrop, (b) dedicated check-in and onsite VIP host, (c) reserved seats for the Miranda Lambert concert at the Ascend Amphitheater and

- attendance at Miranda Lambert's MuttNation Mix & Mingle, (d) group photo with Miranda Lambert, (e) complimentary beverages including Miranda Lambert's MuttNation Mixer specialty cocktail, (f) access to the mini exhibit highlighting Miranda's career and MuttNation milestones, (g) complimentary concessions voucher for a special Miranda autographed item, and (h) VIP MuttNation Paw-ty Pack of MuttNation merchandise; and
- (v) One Thousand Dollars (\$1,000.00) awarded to the Grand Prize winner in the form of a digital reward. Each Grand Prize winner will receive a Prize e-mail. The Grand Prize Winner must then click on the "Reward Link" in the Prize e-mail which will allow the Grand Prize Winner to redeem for a digital Reward. Grand Prize Winner can select his/her choice of Rewards to redeem, reward may not exceed One Thousand Dollars (\$1,000.00).

The approximate retail value ("ARV") of each Grand Prize: Six Thousand Nine Hundred Twenty Dollars (\$6,920.00). The ARV of all prizes awarded in this Sweepstakes is Thirteen Thousand Eight Hundred Forty Dollars (\$13,840.00). NOTE: If due to COVID-19 or other similar restrictions, a concert or series of concerts are canceled, delayed or an audience is not permitted in the stands to watch a concert, then Sponsor may postpone and/or cancel this Sweepstakes. If this Sweepstakes is cancelled or postponed, the Sponsor may adjust the amount and type of Grand Prizes to be awarded or not award any Grand Prizes.

- 6.
