

Chico's + Oprah's Favorite Things Event Sweepstakes

Official Rules

NO PURCHASE NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. Eligibility: Chico's + Oprah's Favorite Things Event Sweepstakes (the "Sweepstakes") is open to legal residents of the 50 United States and the District of Columbia, who have reached the age of majority in their state or territory of residence at time of entry. Void in Puerto Rico and where prohibited by law. Employees of Sponsor, its parents, affiliates and subsidiaries, participating advertising and promotion agencies, independent judging organizations, and prize suppliers (and members of their immediate family and/or those living in the same of household of each such employee) are not eligible. The above entrant requirements apply to both the entrant and, if applicable, his/her travel companion, as the case may be.

2. Sponsor: Chico's FAS, Inc. ("Sponsor"), having a principal place of business at 11215 Metro Parkway, Fort Myers, FL 33966. Wyng has been retained by Sponsor to host the Sweepstakes ("Host"). Random.org has been retained by Sponsor to select one (1) winner ("Judge"). The Sponsor is responsible for the delivery of the Prize(s) to the winner(s).

3. Timing: The Sweepstakes begins on September 26, 2018 at 12:00 a.m. Eastern Time ("ET") and ends on October 17, 2018 at 11:59 p.m. ET (the "Promotion Period").

Sponsor's computer is the official time-keeping device for the Sweepstakes.

4. How to Enter: During the Promotion Period, visit the Sweepstakes page (<http://chicos.com/sweeps>) and follow the links and instructions to complete and submit the registration form ("Submission"). You will automatically receive one (1) entry into the drawing, as well as a unique, sharable link to send to friends. Sharing the unique link is not a requirement to enter or win the Sweepstakes and will not increase chances of winning.

Limit: You may enter one (1) time during the Promotion Period. Any attempt by any entrant to obtain more than the stated number of entries by using multiple/different email addresses, identities, registrations and logins, or any other methods will void that entrant's entries and that entrant may be disqualified. Multiple entrants are not permitted to share the same email address. Use of any automated system to participate is prohibited and will result in disqualification. In the event of a dispute as to any registration, the authorized account holder of the email address used to register will be deemed to be the entrant. The "authorized account holder" is the natural person assigned an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. Each potential winner may be required to show proof of being the authorized account holder.

5. Prize Drawings: Host is an independent organization whose decisions as to the administration and operation of the Sweepstakes are final and binding in all matters related to the Sweepstakes. Judge is an independent judging organization whose decisions as to the selection of the winner is final and binding in all matters related to the Sweepstakes. **At the conclusion of the Promotion Period, Judge will randomly select one (1) winner from all eligible entries received during the Promotion Period.** The winner will be notified by email after the date of the drawing and will be required to respond to the win notification with the information requested within five (5) days of the date notice or attempted notice is sent. Receiving a prize is contingent upon compliance with these Official Rules and winner's execution of an Affidavit of Eligibility and Publicity/Liability Release. If a winner cannot be contacted or provide any other requested information within five (5) days (if applicable), or prize is returned as undeliverable, winner forfeits the prize. In the event the winner is unable to attend the Oprah's Favorite Things event, which is tentatively scheduled for November 7, 2018, then winner will have to forfeit the entire prize and the Sponsor will have the right to select another winner. In the event that a winner is disqualified for any reason, Sponsor will award the prize to an alternate winner by random drawing from among all remaining eligible entries from the Promotion

Period. Only three (3) alternate drawings will be held, after which the prize will remain un-awarded. Prizes will be fulfilled approximately 4 weeks after the conclusion of the Promotion Period.

6. Grand Prize: One (1) prize winner will receive one Chico's gift card (terms and conditions apply) valued at \$500 USD, two tickets to Oprah's Favorite Things Event in New York, NY (tentatively scheduled for November 7, 2018), round-trip coach air transportation for two people from major airport nearest winner's residence (up to \$600 per guest), \$1,200 total for 2 people (ARV: \$1,200), and hotel accommodations (standard accommodations, single room, double occupancy) for 2 people for 3 days, 2 nights (ARV: up to \$250 per night). Total ARV: \$2,200. Hotel accommodations are at Sponsor's discretion, subject to availability. If, in the judgment of Sponsor, air travel is not required due to Winner's proximity to prize location, ground transportation will be substituted for roundtrip air travel at Sponsor's sole discretion and no additional compensation will be provided. Winner must travel on dates specified by Sponsor. Once scheduled, the itinerary cannot be altered and failure of Winner to follow such a schedule shall not obligate Sponsor in any way to provide the Winner with alternate arrangements. In the event the Winner is unable to attend the Oprah's Favorite Things event, which is tentatively scheduled for November 7, 2018, then Winner will have to forfeit the entire prize and the Sponsor will have the right to select another Winner. Winner will be solely responsible for all meals, incidental expenses, tips and gratuities, income and other taxes, ground transportation, and all other costs and expenses not otherwise specified herein. All travelers must possess valid travel documents. The travel companion of Winner must execute a Publicity/Liability Release prior to departure. If actual value is less than stated ARV, difference will not be awarded. ARV is based on average pricing currently available. Prizes may not be substituted except at Sponsor's sole discretion. Sponsor reserves the right to substitute a prize for one of equal or greater value if the designated prize should become unavailable for any reason. Winner is responsible for all taxes and fees associated with prize receipt and/or use. Prizes are not exchangeable or returnable and cannot be substituted for cash or credit.

Approximate Retail Value of all prizes is \$2,200 USD.

7. General Release and Conditions of Participation: By participating in the Sweepstakes or receiving any prize, entrant agrees to release and hold harmless Sponsor, Host, Judge, and their respective subsidiaries, affiliates, suppliers, distributors, advertising/promotion agencies, and prize suppliers, and each of their respective parent companies and each such company's officers, directors, employees and agents (collectively, the "Released Parties") from and against any and all costs, losses, damages, claims or causes of action, including, but not limited to, personal injury, death, or damage to or loss of property, due in whole or in part, directly or indirectly to participation in the Sweepstakes or receipt or use or misuse of any prize.

8. Publicity: Except where prohibited, participation in the Sweepstakes constitutes winner's consent to Sponsor's and its agents' use of winner's name, likeness, photograph, voice, opinions and/or hometown and state for promotional purposes in any media, worldwide, without further payment or consideration.

9. General Conditions: Sponsor reserves the right to cancel, suspend and/or modify the Sweepstakes, or any part of it, if any fraud, technical failures or any other factor beyond Sponsor's reasonable control impairs the integrity or proper functioning of the Sweepstakes, as determined by Sponsor in its sole discretion. Sponsor reserves the right, in its sole discretion, to disqualify any individual it finds to be tampering with the entry process or the operation of the Sweepstakes or to be acting in violation of the Official Rules of this or any other promotion or in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately undermine the legitimate operation of the Sweepstakes may be a violation of criminal and civil law, and, should such an attempt be made, Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law. Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision. Void where prohibited by law.

10. Limitations of Liability: The Released Parties are not responsible for: (a) incomplete, misdirected, late, lost, unintelligible, damaged, or stolen, mail, prize-related documents or prizes; (b) any damage to a entrant's or other person's computer system which is caused or occasioned by participating in the Sweepstakes; (c) technical difficulties or failures of any kind including, but not limited to, lost, interrupted, inaccessible or unavailable networks, servers, satellites, Internet, websites or other connection, availability or accessibility problems arising

in connection with or over the course of the Sweepstakes; (d) miscommunications, failed, jumbled, scrambled, lost, non-delivered or misdirected computer, email, mobile or cable transmissions or hardware, software, program or programming malfunctions, failures or difficulties of any kind; (e) any technical malfunctions, failures or difficulties, printing errors, clerical, typographical or other errors in any sweepstakes advertisement, description or other materials or any Prize related documents; (f) any errors or failures of any kind, whether human, mechanical, clerical, electronic, or technical in nature, or unauthorized human intervention; (g) any incorrect or inaccurate information, associated with, or utilized in the sweepstakes, including, without limitation, entries that are submitted by automated computer programs or other illegitimate means; (h) communications that are undeliverable as a result of any form of active or passive filtering of any kind, insufficient space in a entrant's email or voicemail inbox. If for any reason an entrant's entry is confirmed to have been erroneously deleted, lost, or otherwise destroyed or corrupted, entrant's sole remedy is another entry in the Sweepstakes, if it is possible. If the Sweepstakes, or any part of it, is discontinued for any reason, Sponsor, in its sole discretion, may elect to hold a random drawing from among all eligible entries received up to the date of discontinuance for any or all of the prizes offered herein. No more than the stated number of prizes will be awarded. In the event that production, technical, seeding, programming or any other reasons cause more than the stated number of prizes as set forth in these Official Rules to be available and/or claimed, Sponsor reserves the right to award only the stated number of prizes by a random drawing among all legitimate, un-awarded, eligible prize claims.

11. Disputes: Except where prohibited, entrant agrees that: (1) any and all disputes, claims and causes of action arising out of or connected with this Sweepstakes or any prize awarded shall be resolved individually, without resort to any form of class action, and exclusively by the United States District Court for the Southern District of Florida or the appropriate Florida State Court located in Lee County, Florida; (2) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Sweepstakes, but in no event attorneys' fees; and (3) under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim, indirect, punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of the entrant and Sponsor in connection with the Sweepstakes, shall be governed by, and construed in accordance with, the laws of the State of Florida without giving effect to any choice of law or conflict of law rules (whether of the State of Florida or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the State of Florida.
