A Day You Deserve Contest

Official Rules

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. The SOMA Day You Deserve Contest (the "Contest") begins at 9:00 AM Eastern Time ("ET") March 8, 2020 and ends at 11:59 PM ET March 15, 2020 (the "Entry Period"). This Contest governed by these Official Rules, and is subject to all applicable federal, state and local laws. Void where prohibited by law. This promotion is in no way sponsored, endorsed or administered by, or associated with Facebook.

- 1. Eligibility. The Contest is open legal residents of the 48 contiguous United States and the District of Columbia, aged 21 or older at the time of entry. Employees, officers and directors of Chico's FAS, Inc., d/b/a Soma ("Sponsor"), Sponsor's parent company, affiliates, and subsidiaries (collectively with Sponsor, the "Contest Entities"), as well as the immediate family members and/or those living in the same household (whether legally related or not) of each are not eligible to enter the Contest or win a prize. By participating in the Contest, each entrant unconditionally accepts and agrees to comply with these Official Rules. Failure abide by these Official Rules or other instructions of Sponsor may result in an entrant's disqualification.
- How to Enter. To enter the Contest, complete the official entry [www.facebook.com/somaintimates] and provide a short description (250 words or less) (the "Entry") explaining why you deserve a special day of fun, pampering and indulgence. You may include an image or photograph with your Entry if you like, however it is not a requirement. One entry per person. Incomplete or garbled entry forms or essays will be disqualified. Entries generated by any means intended to circumvent the entry restrictions or fairness of the Contest are void and will be disqualified. All entries submitted become the property of Sponsor and will not be returned. In the event of a dispute over the identity of an online entrant, entry will be deemed submitted by the registered account holder of the email address associated with the entry. If a dispute regarding the identity of the individual cannot be resolved to Sponsor's satisfaction, the affected entry will be deemed ineligible. The Sponsor's designated database clock will be the official timekeeper for this Contest. Sponsor will have complete discretion over interpretation of the Official Rules, the administration of the Contest, and the selection of the winner. Decisions of Sponsor will be final and binding in all aspects of this Contest.
- 3. Judging and Winner Selection. Judging will be conducted on or about March 27. 2020. Each Entry will be scored and ranked based upon the following criteria: (a) Originality/Creativity (33%), (b) Quality of Submission (33%) and (c) Appropriateness of Entry to Contest Theme (34%). The top three highest scoring entries will win. In the event of a tie, winner will be selected based upon their ranking under the Originality/Creativity criterion. The essay portion of the Entry must be original, of entrant's own writing style and creation. Essay must not have been previously published, posted or disseminated, entered in any other contest or violate the rights of any third parties. Essay (or image, illustration or photograph accompanying an Entry, if any) may not be offensive or defamatory, and shall not infringe on the rights (such as the right of privacy) of any third parties. By submitting an entry, each entrant assigns and transfers to Sponsor all rights, title and interest to the essay and any accompanying images. Winner selection conducted by independent judges selected by Sponsor. Decisions of judges are final with respect to all aspects of the Contest.

4. Winner Notification. Potential winners will be notified using the contact information provided on the Entry and will have five (5) business days to respond. Any potential winner who fails to respond within this time frame may be disqualified, their prize award will be declared void and forfeit, and the entrant with the next highest score will be selected as winner. The potential winner will be required to submit an affidavit of eligibility, assignment of rights and release of liability (collectively, the "Winner Documentation") and must return the Winner Documentation within the time period specified by Sponsor in order to receive a prize. Notification is deemed to have occurred immediately upon sending of an email, or placing of a phone call. If any prize notification is undeliverable, or the Winner Documentation is returned incomplete, faulty, or is unclaimed or undeliverable to such potential prize winner, such potential prize winner may be disqualified and an alternate winner may be selected, as outlined above. One (1) winner will receive an all-expenses paid (up to \$4,999) day of indulgence during the 2020 calendar year in their hometown ("Prize Day"). Winner will be able to choose from dining, spa or shopping activities occurring over a 6-8 hour period. Sponsor will consult with the winner on his/her preferred activities and dates. The actual itinerary/schedule of activities and locations shall be determined by Sponsor in its sole discretion. Sponsor shall provide ground transportation for all activities, which must occur within fifty (50) miles of winner's residence. The winner is allowed up to two guests to accompany them on their Prize Day. Guests must be 21 or older; however, winner may, at Sponsor's discretion, plan a Prize Day that includes a winner's minor children (aged six or older); however, all activities planned for the Prize Day must be age appropriate for the participating minors. In the event there is a discrepancy or inconsistency between disclosures or other statements contained in any Contest-related materials, privacy policy or terms of use on any website, social media platform or application and/or the terms and conditions of the Official Rules, the Official Rules shall prevail, govern and control and the discrepancy will be resolved in Sponsor's sole and absolute discretion.

Entrants agree that the Released Parties shall have no responsibility or liability for human error; incorrect or inaccurate transcription of entry information; any technical malfunctions of the telephone network, computer online system, computer dating mechanism, computer equipment, software, or Internet service provider utilized by Sponsor; any interruption or inability to access the website, entry page or any online service via the Internet due to hardware or software compatibility problems; any damage to participant's (or any third person's) computer and/or its contents related to or resulting from any part of the Contest; any lost/delayed data transmissions, omissions, interruptions, viruses, bugs, defects; and/or any other errors or malfunctions, even if caused by the negligence of the Released Parties.
