

## Soma 10 Days of Giveaways Sweepstakes

### Official Rules

**1. Eligibility.** The Soma 10 Days of Giveaways Sweepstakes (the “**Sweepstakes**”) is open only to individuals who are legal residents and physically located in the fifty (50) states in the United States or the District of Columbia and who are at least eighteen (18) years of age at the time/date of entry. Employees, officers and directors of Chico’s FAS, Inc., d/b/a Soma (“**Sponsor**”), Sponsor’s parent company, Wyng, and each of their respective affiliates, subsidiaries, advertising and promotion agencies, distributors and other prize suppliers (collectively with Sponsor, the “**Sweepstakes Entities**”), and each of such employees’, officers’ and directors’ immediate family members and/or those living in the same household (whether legally related or not) of each are not eligible to enter the Sweepstakes or win a prize. For purposes of this Sweepstakes, immediate family members are defined as spouse, partner, parents, legal guardians, in-laws, grandparents, siblings, children and grandchildren and those living in the same household shall mean people who share the same residence at least three (3) months a year, whether legally related or not. **3. How to Enter.** To participate and enter this Sweepstakes, individuals will need a Facebook, Instagram, or Twitter account ("Facebook/Instagram/Twitter Account"). Limit of one (1) entry per person, per Entry Period (i.e., one (1) entry per day) will be accepted. Entrants can earn an additional entry for each friend they refer if that friend also enters the Sweepstakes. Subsequent attempts made by the same individual to submit multiple entries by using multiple or false contact information, accounts or otherwise may result in the entrant being disqualified. Entries generated by a script, computer programs, macro, programmed, robotic or other automated means are void and may be disqualified. Registered account holder is defined as the person assigned to an email address by an Internet access provider, on-line service provider or other organization responsible for assigning email addresses. In the event a dispute regarding the identity of the individual who actually submitted an entry cannot be resolved to Sponsor's satisfaction, the affected entry will be deemed ineligible. The Sponsor's designated database clock will be the official timekeeper for this Sweepstakes. Those who do not follow all of the instructions, provide the required information in their entry form, or abide by these Official Rules or other instructions of Sponsor may be disqualified. The Sweepstakes Entities may run multiple campaigns, contests, sweepstakes or other promotions simultaneously. Entry into one (1) campaign, contest or sweepstakes does not constitute entry into any other.

**4. Winner Selection and Prize Claiming.** There will be one (1) winner selected for each Entry Period for a total of ten (10) winners selected in this Sweepstakes. The potential winners will be selected through a random drawing on or

about the dates set forth on the chart in Section 2 from all eligible entries received in accordance with these Official Rules. Sponsor will have complete discretion over interpretation of the Official Rules, of administration of the Sweepstakes, and of selection of the winner(s). Decisions of the Sponsor as to the selection of the winner(s) will be final. The potential winners will be notified using the information provided during entry by any of email, telephone or mail (method to be selected by Sponsor in its sole discretion) in a commercially reasonable time after the drawing. The Sweepstakes Entities are not responsible for false, incorrect, changed, incomplete or illegible contact information. Notification is deemed to have occurred immediately upon sending of an email, placing of a phone call, one (1) day after sending via a delivery service or two (2) days after mailing. **13. In arbitration, there is no judge or jury and review is limited.
