BEHR WAS THERE SWEEPSTAKES
OFFICIAL RULES**

**NO PURCHASE NECESSARY. PURCHASE WILL NOT INCREASE ODDS OF WINNING.
VOID WHERE PROHIBITED.**

1. **PROMOTION TIMING.** The **BEHR WAS THERE SWEEPSTAKES** begins at 12:00:01 P.M. Pacific Time (“PT”) on May 12th, 2022 and ends 11:59:59 P.M. PT on June 9th, 2022 (the “**Promotion Period**”).
2. **ELIGIBILITY.** The Promotion is open only to individuals who at the time of entry (a) are legal residents of and domiciled in the fifty (50) United States or the District of Columbia, and (b) are at least 18 years of age. The following individuals are not eligible to participate: (i) employees of **BEHR PAINT COMPANY** (“**Sponsor**”) or Masco Corporation, any of their subsidiaries or affiliate companies, or their advertising, marketing or promotional agencies; (ii) family members (spouse, parents, siblings, children and in-laws) of any individual referred to in clause (i); and (iii) persons living in the same household (whether or not related) with any person referred to in clause (i) or (ii) above.
