

Drury Hotels' Ultimate Road Trip Sweepstakes Official Rules (the "Official Rules")

NO PURCHASE NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

Eligibility: Drury Hotels' Ultimate Road Trip Sweepstakes (the "Sweepstakes") is open only to registered guests of any Drury Hotel with a valid registration as of the start date of the applicable Sweepstakes Period (as defined below), who are legal residents of Canada (excluding Quebec) or the United States, and are at least eighteen (18) years old at the time of entry, and have reached the age of majority in his/her state, province or territory of residence, if above the age of 18. Employees of Drury Hotels Company, LLC, its affiliates and subsidiaries, and employees' immediate families, are not eligible or allowed to participate. **THE SWEEPSTAKES IS SUBJECT TO ALL APPLICABLE FEDERAL, STATE, PROVINCIAL AND LOCAL LAWS AND REGULATIONS AND IS VOID WHERE PROHIBITED BY LAW.** Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor's decisions, which are final and binding in all matters related to the Sweepstakes. Sweepstakes Period: Thursday, April 30, 2026, at 12:00 p.m. Central Standard Time (CST) through Wednesday, May 6, 2026, at 11:00 a.m. CST (the "Sweepstakes Period"). Sponsor's computer is the official time-keeping device for the Sweepstakes. Drawing for the winner will take place on Wednesday, May 6, 2026, St. Louis, Missouri, at approximately 11:00 a.m. CST.

How to Enter: During the Sweepstakes Period, users can visit <http://www.facebook.com/DruryHotels> and fill out the form in order to be entered for a chance to win. By completing this form, you will automatically receive one (1) entry into the Sweepstakes. All entries become the property of the Sponsor. By entering, you acknowledge and agree to these Official Rules, including eligibility requirements, and you agree that all decisions of Sponsor are final and binding. Answers to questions on the form must not be indecent, defamatory, libelous, offensive, violent or contain material unlawful in any way. If participating via your mobile device, message and data rates may apply. No correspondence about entries will be acknowledged. Duplicate entries will be disqualified.

Limit: You may only enter one (1) time during the Sweepstakes Period. Each entrant will be entered to win one (1) Prize. Multiple entrants are not permitted to share the same email address. Any attempt by an entrant to exceed entry restrictions by using multiple/different email addresses, identities, registrations and logins, or any other methods will void that entrant's entries and that entrant may be disqualified. Use of any automated system to participate is prohibited and will result in disqualification. In the event of a dispute as to any registration, the authorized account holder of the email address used to register will be deemed to be the entrant. The "authorized account holder" is the natural person assigned an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted email address. Eligible Winner Notification and Confirmation Process: The eligible winner will be notified via email by the Sponsor or its designated representative. Confirmed winners will receive the applicable prize by mail at the address provided, approximately four (4) to six (6) weeks after end of Sweepstakes Period.

Sponsor reserves the right, in its sole and absolute discretion, to disqualify any individual that Sponsor finds to be tampering with the entry process or the operation of the Sweepstakes or to be acting in violation of these Official Rules. Any attempt by any person to deliberately undermine the legitimate operation of the Sweepstakes may be a violation of criminal and/or civil law, and, should such an attempt be made, Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law. Sponsor's failure to enforce any provision of these Official Rules shall not constitute a waiver of that provision.

Limitations of Liability: The Released Parties are not responsible for: (1) any incorrect or inaccurate information, whether caused by entrants, printing errors or by any of the equipment or programming associated with or utilized in the Sweepstakes; (2) technical failures of any kind, including, but not limited to malfunctions, interruptions, or disconnections in phone lines or network hardware or software; (3)
