

76® ULTIMATE RV TAILGATING EXPERIENCE SWEEPSTAKES OFFICIAL RULES

If you participate via mobile device, message and data rates may apply.

The 76® Ultimate RV Tailgating Experience Sweepstakes (the “Sweepstakes”) is sponsored by Motiva Enterprises LLC (“Motiva”) and Lazydays RV (“Lazydays”, and together with Motiva, the “Sponsors” and each, a “Sponsor”).

1. ELIGIBILITY:

A. NO PURCHASE IS NECESSARY TO ENTER OR CLAIM A PRIZE. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. The Sweepstakes is open to legal residents of the 50 United States and the District of Columbia, age eighteen (18) years or older at the time of entry, except employees, their spouses and immediate families (parent, child, sibling, and any of their respective spouses) and household members (whether or not related) of Motiva, Lazydays, Learfield IMG College, LLC (“Administrator”), University of Florida Athletic Department, and each of their respective parent, subsidiaries, divisions, trustees, franchisees, participating vendors, distributors, cable affiliates, advertising and promotion agencies and affiliated entities (collectively, including Sponsors, the “Sweepstakes Entities”).

There is one (1) way to enter the Sweepstakes:

(i) Entrant can visit <https://floridagators.com/RVtailgate> and follow the instructions to complete and submit the online form, including entrant’s name, address, telephone number, email address, and any other information requested on the form. Entrant will receive one (1) entry for each qualified submission. To be eligible, each Sweepstakes entry must be received no later than 11:59 p.m. CT on Tuesday, October 1, 2019.

B. Entries generated by script, macro or other automated means will be void. The Sweepstakes Entities are not responsible for misdirected, incomplete, lost, late, illegible, undelivered, inaccurate or delayed entries, or for technical, hardware, or software failures of any kind, lost or unavailable network connections, or failed, incomplete, garbled or delayed computer transmissions or other errors or problems that may limit or affect a person’s ability to participate in the Sweepstakes, whether human, mechanical, typographical, printing, electronic, network or otherwise, relating to or in connection with the Sweepstakes, including, without limitation, errors that may occur in connection with the administration of the Sweepstakes, the processing of entries, the announcement of the prizes or in any Sweepstakes-related materials. 3. HOW TO WIN:

A. At approximately 5:00 p.m. CT on Friday, October 4, 2019, one (1) potential winner (when verified by Sponsors and Administrator as set forth below, the “Winner”) will be selected in a random drawing from all eligible entries received. The potential Winner will be notified by a Sponsor or Administrator via email and/or telephone and must meet all eligibility requirements, including timely replying to the notification (as set forth below) and execution and return of all necessary releases and documents (if any) required by a Sponsor and/or Administrator. Winning a prize is contingent upon fulfilling all requirements set forth in these Official Rules. Odds of winning depend on the number of eligible entries received.

B. If there is a dispute as to the identity of a Winner, the winning entry will be declared to have been made by the authorized email account holder at time of entry.
