

**MASTERCHEM INDUSTRIES LLC.
KILZ® DIY DO-OVER SWEEPSTAKES OFFICIAL RULES**

**NO PURCHASE NECESSARY. A PURCHASE WILL NOT INCREASE ODDS OF WINNING.
VOID WHERE PROHIBITED.**

1. PROMOTION TIMING. The KILZ DIY Do-Over Sweepstakes (the "Promotion") begins at 9:00 A.M. Pacific Time ("PT") on August 28, 2018 and ends 11:59:59 P.M. PT on September 25, 2018 (the "Promotion Period"). The Sponsor's (defined below) computer is the Promotion official clock.

2. ELIGIBILITY. The Promotion is open only to individuals who at the time of entry (a) are legal residents of and domiciled in the fifty (50) United States or the District of Columbia, and (b) are at least eighteen (18) years of age. The following individuals are not eligible to participate: (i) employees of Masterchem Industries LLC ("Sponsor") or Masco Corporation, any of their subsidiaries or affiliate companies, or their advertising, marketing or promotional agencies; (ii) family members (spouse, parents, siblings, children and in-laws) of any individual referred to in clause (i); and (iii) persons living in the same household (whether or not related) with any person referred to in clause (i) or (ii) above. 3. HOW TO ENTER. There are two (2) ways to enter the Promotion:

BY SUBMITTING A PHOTO, ENTRANT AGREES THAT THE PHOTO, ALONG WITH HIS/HER FIRST NAME, AND LAST INITIAL, MAY BE POSTED ON THE WEBSITE, OTHER SOCIAL MEDIA PLATFORMS, INCLUDING BUT NOT LIMITED TO OTHER PAGES ON FACEBOOK, TWITTER, ETC., THE INTERNET, TELEVISION, RADIO, AND PRINT AT SPONSOR'S SOLE DISCRETION, AND ENTRANTS ACKNOWLEDGE THAT THEIR ENTRIES MAY BE REPOSTED BY THE PUBLIC OR OPEN TO PUBLIC COMMENTARY, FOR WHICH SPONSOR AND THE SWEEPSTAKES ENTITIES SHALL NOT BE LIABLE.

PHOTO GUIDELINES AND REQUIREMENTS: Each Photo:

- Must be in one of the following formats: .JPEG, .JPG, .GIF, or .PNG;
- Must not exceed 5 MB;
- Must not contain material that violates or infringes another's rights, including, but not limited to, privacy, publicity or intellectual property rights, including copyright infringement, or legal or moral rights of any third party, living or deceased;
- Must not disparage Sponsor, Administrator or any other person or party affiliated with the promotion and administration of this Sweepstakes;

- Must not include any personally identifiable information;
- Must be the original work of the entrant and must not contain images or artwork, music, quotes, parodies or other materials not created by entrant;

- Must not contain material that is unlawful, in violation of or contrary to the laws or regulations in any jurisdiction where the Photo was created.

Entrant must have approval from any persons appearing in the Photo and be able to provide express written consent of every such person appearing in the Photo to Sponsor and/or Administrator if requested.

NOTE: If any Photo fails to comply with any of these Photo Guidelines and Requirements or any other provisions of these Official Rules, Sponsor reserves the right to disqualify the Entrant and he/she will not be eligible to win.

B. Alternate Method of Entry: In the alternative, if you do not wish to enter the Promotion by submitting an Entry as described above, you may enter the Promotion by providing your contact information here: <http://spr.ly/6001DqDaT> by 11:59 P.M. PT on September 25, 2018.

All Entries become the property of Sponsor and will not be acknowledged or returned. **Limit one (1) Entry per person during the Promotion Period, regardless of the means of Entry.** If more than the stated number of Entries are received from the same person, telephone number and/or e-mail address, the Entries may, at the Sponsor's sole discretion, be disqualified. Entrants are prohibited from using more than one (1) e-mail address or multiple identities. If it is found or suspected that an Entrant is using more than one e-mail address or multiple identities to participate in the Promotion, then that entrant, in Sponsor's sole discretion, may not be eligible to win a prize. Entries will not be acknowledged or returned. Proof of sending or submitting an Entry will not be deemed proof of receipt by Sponsor.

4. AGREEMENT TO OFFICIAL RULES. Your participation in this Promotion constitutes your full and unconditional agreement to and acceptance of these Official Rules and the decisions of the Sponsor, which are final and binding. 5. SELECTION OF PRIZE WINNERS. On or around October 2, 2018, one (1) potential grand prize winner ("Grand Prize Winner") and five (5) potential first prize winners (each a "First Prize Winner") (collectively

each a potential "Prize Winner") will be selected by Sponsor in a random drawing from among all eligible Entries received. Odds of winning depend on the total number of eligible Entries received during the Promotion Period. Entries drawn will not be eligible for any subsequent drawing. Entries not drawn will be carried-over into subsequent drawings. A purchase will not increase the chances of winning. Each winner is considered a potential winner pending verification of his/her eligibility and compliance with these Official Rules.
