## OFFICIAL SWEEPSTAKES RULES (“Official Rules”)

**1. ELIGIBILITY & CONDITIONS OF PARTICIPATION:** Open only to residents of the 50 United States and the District of Columbia at the time of entry, who are at least eighteen (18) years of age (or the age of majority in your state of residents, whichever is older at the time of entry (“**Entrant**”).
