

Dollar Tree Customer Appreciation Sweepstakes Official Rules

SWEEPSTAKES DATES

The Dollar Tree Customer Appreciation Sweepstakes (the "Promotion") is being held by Dollar Tree Stores, Inc. ("Dollar Tree"). The Sweepstakes begins at 8:30am Eastern Time ("ET") on Monday, April 1, 2019 and closes at 11:59pm Eastern Time ("ET") on Friday, April 5, 2019 (the "Promotion Period"). Entries received other than during the Promotion Period will be disqualified.

ELIGIBILITY

No purchase is necessary to enter or win. The Promotion is void wherever prohibited or restricted. All applicable federal, state, and local laws and regulations apply. The Promotion is open only to legal residents of the contiguous forty-eight (48) United States and the District of Columbia who are age eighteen years old (18) or older and have reached the age of legal majority in their state of residence as of April 1, 2019. A person who complies with all the eligibility rules shall be referred to as "Entrant." Employees of Dollar Tree and its subsidiaries, affiliates, licensees, service providers, prize suppliers, agents, advertising or promotion agencies, and those involved in the production, development, implementation or handling of Promotion (collectively, the "Promotion Entities"), and/or the immediate family (parent, child, sibling, or spouse) or household member (whether or not related) of any such employee are not eligible to participate in this Promotion. Non-compliance with these Official Rules shall result in disqualification from the Promotion.

PRIZES

One winner will receive a grand prize of one (1) \$500 Dollar Tree gift card. There will be seventy-five (75) runner-up winners who will receive one (1) \$50 Dollar Tree gift card. Each winner is responsible for the reporting and payment of all state, federal, and local taxes applicable to the receipt of a prize. No transfer, assignment, cash redemption, or substitution of a prize is permitted except that Dollar Tree reserves the right, in its sole and absolute discretion, to substitute a prize with a prize of comparable or greater value or cash value. In the event that a prize cannot be awarded for any reason or a winner is not capable of redeeming a prize for any reason, Dollar Tree shall not be obligated to award any prize. If, for any reason, more than the stated number of prizes are claimed, Dollar Tree reserves the right to award the prizes in such category by random drawing from among eligible prize claimants in such prize category or in a manner to be determined by Dollar Tree in its sole and absolute discretion. HOW TO ENTER

To enter, Entrant must provide us with your email address, name, address, and phone number on the campaign webpage (the "Entry" or "Entries"). One Entry will be allowed per person or email address into the sweepstake for a chance to win. Customers submitting multiple names and/or multiple email addresses will be disqualified. The award of a prize is contingent upon Entrant complying with all conditions and fulfilling all requirements set forth herein. Entries must include all of the required information as set forth in the submission form and herein or will be deemed ineligible.

WINNER SELECTION

Between April 8 and April 18, one (1) potential grand prize winner as well as seventy-five (75) potential runner-up winners will be selected at random from among all eligible entries received. The odds of being selected as a potential winner depend on the number of eligible entries received. Winners will be announced by May 1, 2019.

HOW TO CLAIM PRIZE

Potential winners will be notified via email through email address supplied during the Promotion entry and will be asked to provide their full name, age, and mailing address within a specific time period. Prizes will be mailed within three (3) weeks of receipt of winner's details. If a potential winner cannot be contacted within three (3) days of the first attempt to contact him/her, or does not respond within the timeframe stated in the notification, Dollar Tree may select an alternate potential winner in his/her place.

If chosen, use your gift card(s) at any Dollar Tree store or online at DollarTree.com. Plus, your card(s) will never expire, so you can shop on your own terms.

To redeem your gift card(s), simply follow these instructions:

- For in-store redemption, present the card to the sales associate at the time of purchase.
- For online orders, enter the 19-digit card number (directly above the magnetic strip on the back of the card) in the "Billing & Payment" box during checkout.
- If your purchase exceeds the funds available on your gift card, don't worry... you can simply enter an additional form of payment.

PRIVACY AND PUBLICITY
