## **DESTINATION XL® "MVP COLLECTIONS GIVEAWAY-A-DAY" SWEEPSTAKES**

## **OFFICIAL RULES**

## NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN.
