

**CETAPHIL® “SELF-CARE CELEBRATION” SWEEPSTAKES
FULL OFFICIAL RULES**

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

BY SUBMITTING AN ENTRY IN THIS SWEEPSTAKES, YOU UNDERSTAND, AGREE AND CONSENT TO THE USE OF THE ENTRY SELFIE BY SPONSOR AS AUTHORIZED HEREIN.

A MOBILE DEVICE/SMARTPHONE IS NOT REQUIRED TO PARTICIPATE IN THIS SWEEPSTAKES, BUT IF A MOBILE DEVICE/SMARTPHONE IS UTILIZED TO PARTICIPATE IN THIS SWEEPSTAKES, CARRIER’S STANDARD DATA RATES APPLY.

- 1. ELIGIBILITY:** The Cetaphil® “Self-Care Celebration” Sweepstakes (the “Sweepstakes”) is open to legal U.S. residents currently residing in the 50 United States or the District of Columbia, who are at least 18 years of age or the age of majority in their state of residence, whichever is older, at the time of entry. Employees of Galderma Laboratories, LP (“Sponsor”) and its parent, affiliates, subsidiaries, franchisees, and advertising, promotion and fulfillment agencies, and their affiliates are not eligible to enter or win, nor are such employees’ immediate family members (defined as spouses, parents, siblings or children, whether biological, adopted, step or in-law) or such employees’ household members (whether related or not). Void where prohibited by law. Sweepstakes is subject to all federal, state and local laws and regulations. Internet access and a valid e-mail address are required to participate.
- 2. SWEEPSTAKES PERIOD:** The Sweepstakes begins at Midnight ET on October 1, 2018, and ends at 11:59:59 p.m. ET on November 16, 2018 (the “Sweepstakes Period”).
- 3. TO ENTER:** To enter, take a photo of yourself (a “Selfie”) and follow the instructions on-screen at cetaphil.wyng.com/SELFCARECELEBRATION (the “Web site”) to upload and customize your Selfie by indicating what “Self-Care Celebration” means to you. Then, complete the online registration form (“Entry Form”) by entering your full name and e-mail address and submit both the entry form and Selfie (collectively the “Entry”) during the Sweepstakes Period. **Data rates may apply if you participate or access the Web site via your mobile device.** At the time of registration, entrants may opt in to receive future communications from Sponsor, which may be unrelated to this Sweepstakes.
- 4. ENTRY REQUIREMENTS:** The following requirements for Entries shall apply (“Entry Requirements”), and failure to comply with Entry Requirements may result in disqualification, in Sponsor’s sole discretion:
 - a.** Entry Form must be completed in English.
 - b.** Selfie must be uploaded at time of submission of the Entry Form, and can be uploaded from your desktop computer or mobile device.

- c. Selfie must not exceed 5 MB in file size and must be submitted in JPG, JPEG, GIF, BMP, TIFF or PNG file format. Animated GIFS will act as static images when uploaded.
- d. The Entry must be the sole, original work of the entrant.
- e. The person in the Selfie must be the photographer as well as the entrant.
- f. No person may appear in the Selfie other than the entrant.
- g. The Selfie must not infringe upon the rights of any third party, including, without limitation, copyright, trademark, rights of publicity and/or privacy.
- h. The Selfie must be suitable for publication to all audiences, and may not be violent, immoral, offensive, illegal, pornographic, obscene, indecent, inappropriate, contain any activity deemed to be dangerous or to promote unsafe behavior, or in any way inconsistent with Sponsor's desired image, as determined solely by Sponsor.
- i. The Selfie must not prominently feature any logo, trademark, service mark, or other image of any business or company other than Sponsor's Cetaphil brand. Inclusion of Cetaphil product(s) is not required and will not increase Entrant's chance of winning.
- j. The Selfie must not show Sponsor's product(s) or product packaging being used inappropriately or in a disparaging manner, or in any manner portray Sponsor or any of its brands negatively.
- k. The Entry must be in keeping with Sponsor's image, as determined by Sponsor in its sole discretion.
- l. The Entry may not in any other way violate applicable laws and regulations.

Sponsor will post Entrant's Selfie on the Web site provided it meets the Entry Requirements. Any Entry that does not comply with the Entry Requirements or is otherwise deemed by Sponsor in its sole discretion to be in violation of these Official Rules will be disqualified. By submitting an Entry in this Sweepstakes, entrant agrees to indemnify and hold harmless Sponsor, any other person or entity involved in the administration, execution or fulfillment of the Sweepstakes, and all of their respective parent or affiliated entities, owners, officers, directors, employees, shareholders, members, agents or contractors (collectively "Related Parties") from any and all claims, damages, expenses, costs (including reasonable attorneys' fees) and liabilities (including settlements), brought or asserted by any third party against Sponsor or Related Parties due to or arising out of the entrant's entry, the use of such Entry (in whole or part, edited or unedited) by Sponsor or any other party authorized by these Official Rules or Sponsor, or the entrant's conduct in creating an Entry, including but not limited to claims for trademark infringement, copyright infringement, violation of an individual's right of publicity or right of privacy, or defamation. Entrant further agrees to release Sponsor and Related Parties from any and all claims that any commercial, advertising presentation, Web content or any other material subsequently produced, presented, and/or prepared by or on behalf of Sponsor infringes entrant's rights with regard to any elements, characters or ideas contained in any Entry.

Entries are not being judged. Neither the content of an Entry (other than confirming it complies with eligibility and content requirements) or the posting of a Selfie to the Web site will have any bearing on winner determination.

5. ENTRY LIMITATIONS:

- a. You may enter once per day during the Sweepstakes Period using a different Selfie for each entry. A “day” is defined as the 24-hour period beginning at Midnight ET on any individual calendar date during the Sweepstakes Period and ending at 11:59:59 p.m. ET on that date. If more than one Entry is received from a person in the same day, all but the first Entry will be disqualified.
- b. **General Limitations:** Entries will not be acknowledged. Each person may only use one (1) e-mail address to participate in this Sweepstakes, and such e-mail address may only be used by one person regardless of whether the e-mail address is shared by two (2) or more people. Any participant who uses more than one (1) e-mail address to enter this Sweepstakes may be disqualified and any prizes won may be forfeited subject to Sponsor’s sole discretion. If a dispute arises regarding who submitted an online Entry, the Entry will be deemed to be submitted by the person named in the Entry Form, and if that person is not the Authorized Account Holder of the email address, then such Entry may be disqualified. The “Authorized Account Holder” is defined as the natural person who is assigned to an e-mail address by an Internet access provider, online service provider or other organization responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address. No mass or mechanically reproduced Entries will be accepted. By entering this Sweepstakes, entrants accept and agree to be bound by these full Official Rules and the decisions of the judges, which shall be final, binding and conclusive on all matters.

- 6. GRANT OF RIGHTS BY ALL ENTRANTS:** BY SUBMITTING AN ENTRY, ENTRANT ACKNOWLEDGES THAT THEIR SELFIE MAY BE POSTED ON THE WEB SITE. Entrant acknowledges that Sponsor has no obligation to use or post any Selfie submitted. By submitting an Entry, entrant agrees that his/her Entry is freely made, without restriction, and will not place Sponsor under any obligation, and that Sponsor is free to disclose or otherwise use the Entry without any compensation to the entrant.

Each entrant grants Sponsor the right (but not the obligation) to include his/her name in connection with Sponsor’s authorized use of the Entry, in Sponsor’s sole discretion. Each entrant waives any and all “Moral Rights” that may be claimed in the Entry and waives all claims to receive royalties of any kind now or in the future from Sponsor or its designees for use of his/her Entry as authorized herein. Entrant acknowledges that Released Parties will not be responsible for any use by the public of entrant’s Selfie and forever releases and holds the Released Parties harmless from and against any liability of any kind arising from or in connection with any such use.

By submitting an Entry and accepting a prize, winners grant to Sponsor and Released Parties (defined in Rule 12, below) an unlimited, royalty-free, worldwide, perpetual license and right to publish, use, modify, edit and publicly perform the Entry in any way, in any and all media, without limitation, and without consideration to the entrant.

Entrant acknowledges and agrees that Sponsor has not, nor will have in the future, any duty or liability, direct or indirect, vicarious, contributory, or otherwise, with respect to the infringement or protection of any copyright or other intellectual property right in and to the Entry. Entrant agrees to indemnify and hold harmless Sponsor and Released Parties from any claims to the contrary.
- 8. WINNER SELECTION:** Five (5) potential winners will be randomly selected from all eligible Entries received during the Sweepstakes Period in a drawing to be held on or about November 30, 2018. The drawing will be conducted by an independent judging agency, whose decisions are final and binding. Limit one (1) prize per person/household. Fulfillment agent will make two (2) attempts to notify the winner by e-mail at the e-mail address provided at the time of entry. If, after five (5) days from the initial attempted notification, contact has not been made, prize will be forfeited and an alternate winner will be randomly selected. Winner will be required to complete an Affidavit of Eligibility and Publicity/Liability Release (except where prohibited by law) which shall include providing winner's social security number for tax identification purposes as a condition of receiving the prize. Trip package includes: (i) Roundtrip coach class air transportation for winner and one (1) guest from the major airport nearest the winner's residence to the major airport nearest spa; (ii) ground transportation to and from airport and spa; (iii) four (4) days/three (3) nights standard double-occupancy accommodations; (iv) a selection of spa services; (v) meals; (vi) \$2,000 spending money awarded in the form of a check made payable to the winner. ARV: up to \$15,100.
