

## Knorr 2024 Holiday “Buy \$10, Get \$5 back” Gift with Purchase Program

### Offer Terms and Conditions

#### 1. AGREEMENT TO BE LEGALLY BOUND BY TERMS AND CONDITIONS:

By participating in the Knorr 2024 Holiday Gift with Purchase Offer (the “**Offer**”), you are signifying your agreement that you have read and agree to be legally bound by these official terms and conditions (the “**Terms**”).

#### 2. KEY DATES:

The Offer consists of: (i) a purchase period, starting October 1, 2024 at 12:00 a.m. Eastern Time (“**ET**”), and ending on December 31, 2024 at 11:59 p.m. ET (the “**Purchase Period**”); and (ii) a submission period, starting October 1, 2024 at 12:00 a.m. ET, and ending on January 15, 2025 at 11:59 p.m. ET or once all Rewards (defined below) have been awarded, whichever comes first (the “**Submission Period**”). The Purchase Period and Submission Period shall be collectively referred to as the “**Offer Period**”.

#### 3. ELIGIBILITY:

- iii. confirm that you are of the age of majority in your province/territory of residence and that you have read and accept these Rules;
- iv. answer correctly, without assistance of any kind, whether mechanical or otherwise, the mathematical skill-testing question;
- v. indicate whether you would like to receive future notifications regarding upcoming events and/or promotions from the Sponsor (for certainty, opting-in to receive such notifications is optional and will not impact the submission); and
- vi. click “Submit” to conclude your submission.

No reproductions permitted. Each Eligible Purchase receipt may only be submitted once; duplicate submissions of Eligible Purchase receipts will be disqualified. Standard data rates apply to participants who choose to participate via a mobile device. Please contact your service provider for pricing and service plan information and rates before mobile device participation. **IMPORTANT NOTE: Please retain your original Eligible Purchase receipt, as it may be required to be presented to the Sponsor as part of the verification procedure outlined below.**

## **5. LIMITS AND CONDITIONS:**

Limit one (1) Reward per Eligible Purchase receipt (regardless of the number of Participating Products purchased) and per Submission. Limit one (1) Reward per person. This Offer cannot be combined with any other offer, discount or promotion. Limited time offer, while quantities last. Reward will be fulfilled on a first come, first serve basis of uploaded and validated submissions. Math skill testing question required.
