

Walmart Gift Card – Unilever Winter Essentials 2024

Offer Terms and Conditions

1. AGREEMENT TO BE LEGALLY BOUND BY TERMS AND CONDITIONS:

By participating in the 2024 Unilever Winter Essentials Offer (the “**Offer**”), you are signifying your agreement that you have read and agree to be legally bound by these official terms and conditions (the “**Terms**”).

2. KEY DATES:

The Offer consists of: (i) a purchase period, starting October 24, 2024 at 12:00 a.m. Eastern Time (“**ET**”), and ending on December 11th, 2024 at 11:59 p.m. ET (the “**Purchase Period**”); and (ii) a submission period, starting October 24th, 2024 at 12:00 a.m.ET, and ending on December 21, 2024 at 11:59 p.m. ET or once all Rewards (defined below) have been awarded, whichever comes first (the “**Submission Period**”). The Purchase Period and Submission Period shall be collectively referred to as the “**Offer Period**”.

3. ELIGIBILITY:

Participation in the Offer is only open to legal residents of Canada who have reached the legal age of majority in their province or territory of residence at the time of participation. Despite the foregoing, employees, representatives or agents (and those with whom such persons are living in the same household, whether related or not, and/or immediate family members) of Unilever Canada Inc. (the “**Sponsor**”) and any of their respective affiliated and related companies (including, without limitation, each of their respective parent, sister and subsidiary companies), advertising and promotional agencies, or other party in any way involved in the development or administration of this Offer (collectively, the “**Offer Parties**”) are excluded from participation in the Offer. 4. HOW TO REDEEM:

Visit a Walmart location in Canada (including its direct online retail channel(s)) (“**Walmart**”) and purchase, in a single transaction during the Purchase Period, spend thirty (30) dollars or more on participating Unilever products (as set out in Appendix A, below) (each, a “**Participating Product**”) (for greater certainty, trial and travel sizes are excluded, and gift packs, special packs, and bundle packs are also excluded; i.e., these are not Participating Products) while supplies last (collectively, an “**Eligible Purchase**”) during the Submission Period;
- ii. visit <https://unileverwinteressentials.ca/> (the “**Website**”); and
- iii. follow the on-screen instructions on the Website to submit, during the Submission Period: (a) a photo of your Eligible Purchase receipt, and (b) your first name, last name, valid email address, postal code and phone number (collectively, a “**Submission**”),

you will be eligible to receive one (1) \$10 Walmart Gift Card (a “**Reward**”)reward.

To be eligible, your Eligible Purchase receipt must fully evidence that you have made an Eligible Purchase during the Purchase Period (including clearly showing the Participating Products purchased, dollar amount of Participating Products purchased, and Eligible Purchase date, time and that the purchase was made at/from Walmart – all other information that is not required by these Terms may be redacted). Your Submission must be submitted and received in accordance with these Terms during the Submission Period (as determined by the Sponsor in its sole and absolute discretion). No reproductions permitted. Each Eligible Purchase receipt may only be submitted once; duplicate submissions of Eligible Purchase receipts will be disqualified. before mobile device participation. **IMPORTANT NOTE: Please retain your original Eligible Purchase receipt, as it may be required to be presented to the Sponsor as part of the verification procedure outlined below.**

5. LIMITS AND CONDITIONS:

Limit one (1) Reward per Eligible Purchase receipt (regardless of the number of Participating Products purchased; for example, if your Eligible Purchase receipt shows that you have purchased six (60) dollars on Participating Products, you will only be eligible to receive one (1) Reward) and per Submission. Limit 1 Reward per Household. This Offer cannot be combined with any other offer, discount or promotion.

All Eligible Purchase receipts, Submissions and any other content, materials or information in any way connected with this Offer (collectively, “**Offer-Related Information**”) and participants are subject to verification at any time and for any reason. The Sponsor reserves the right, in its sole and absolute discretion, to require proof of a valid Eligible Purchase receipt, identity and/or eligibility (in a form acceptable to the Sponsor) for the purposes of verifying the eligibility and/or legitimacy of any Offer-Related Information entered (or purportedly entered) for the purposes of this Offer and/or for any other reason the Sponsor deems necessary, in its sole and absolute discretion, for the purposes of administering this Offer in accordance with these Terms. Upon receipt of an eligible Submission in accordance with these Terms and successful validation (as determined by the Sponsor, in its sole and absolute discretion) a Reward will be delivered via email, to the address provided with the Submission through the Website. Typical processing time is approximately 72 hours from successful validation (and validation typically takes 48 hours) of Submissions for delivery (and delivery typically takes 1-2 weeks from successful validation) of Rewards.

No responsibility is assumed by the Released Parties for any Rewards sent by mail that are returned as undeliverable, or for any Reward after it has been sent to a participant.
