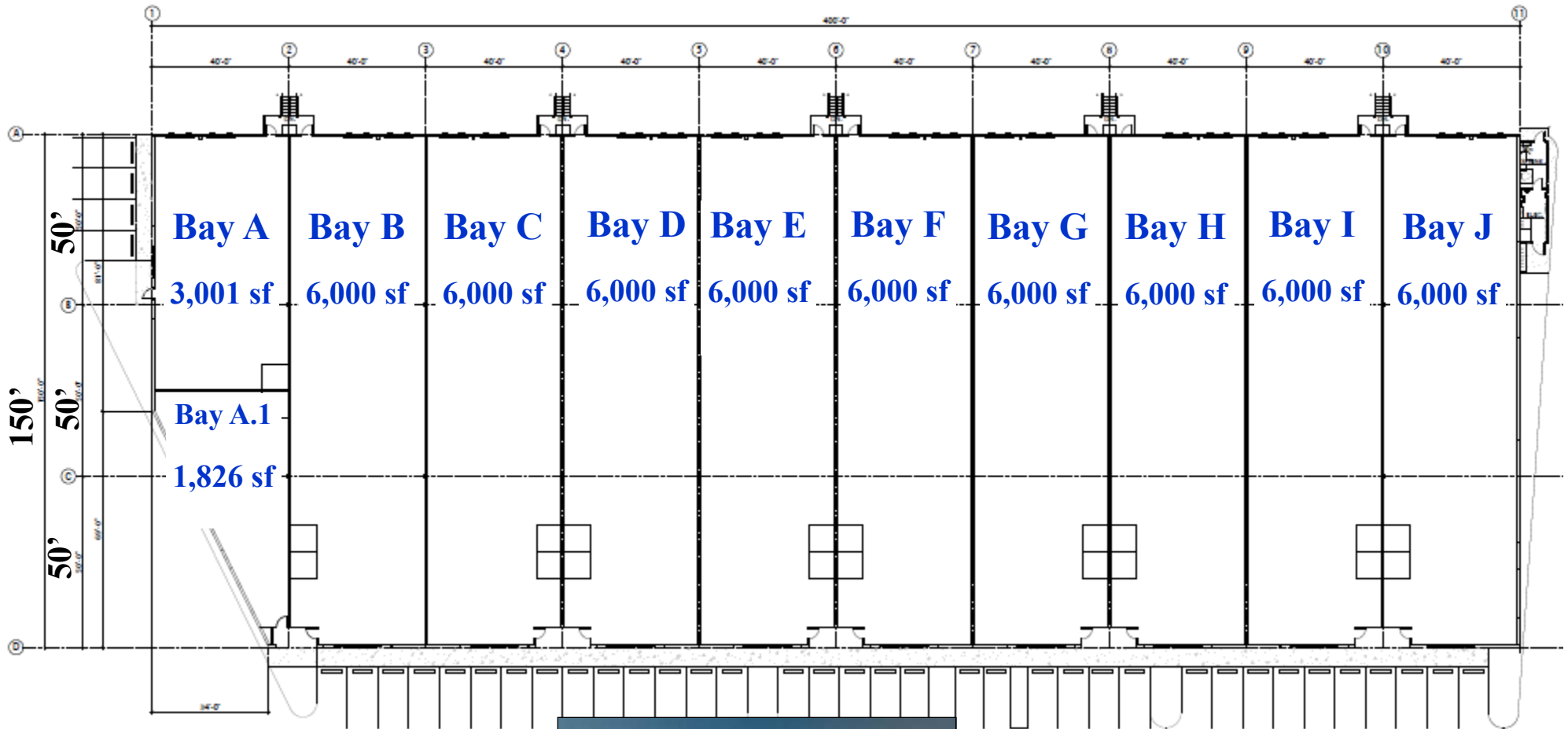

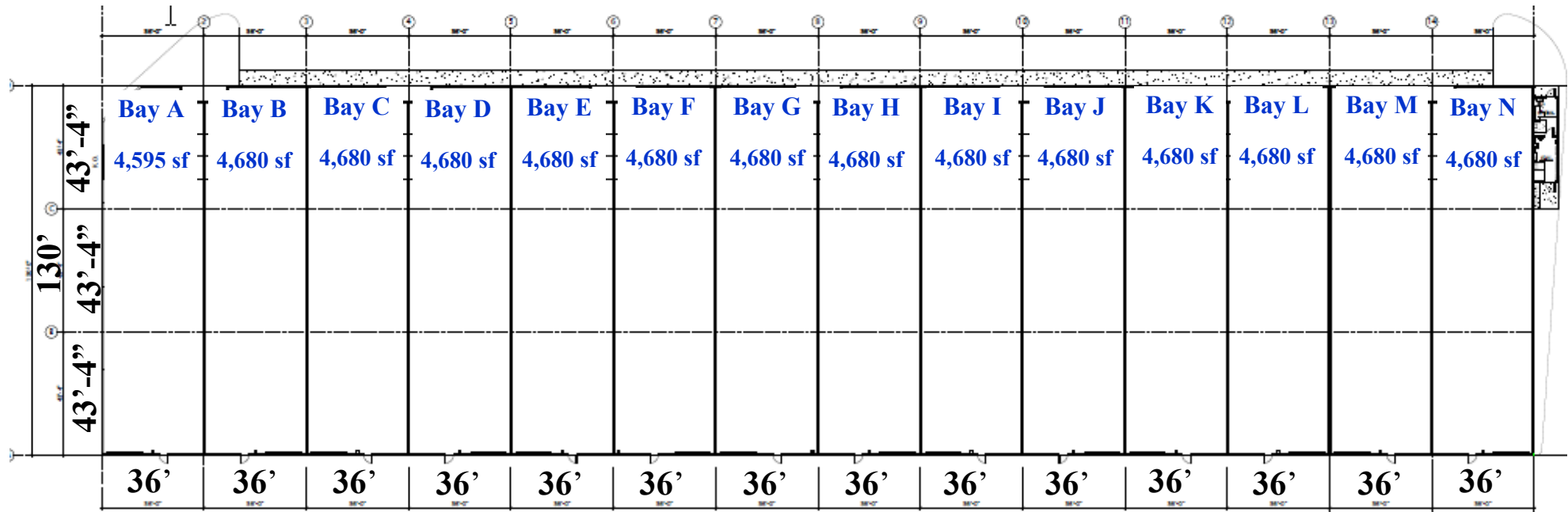

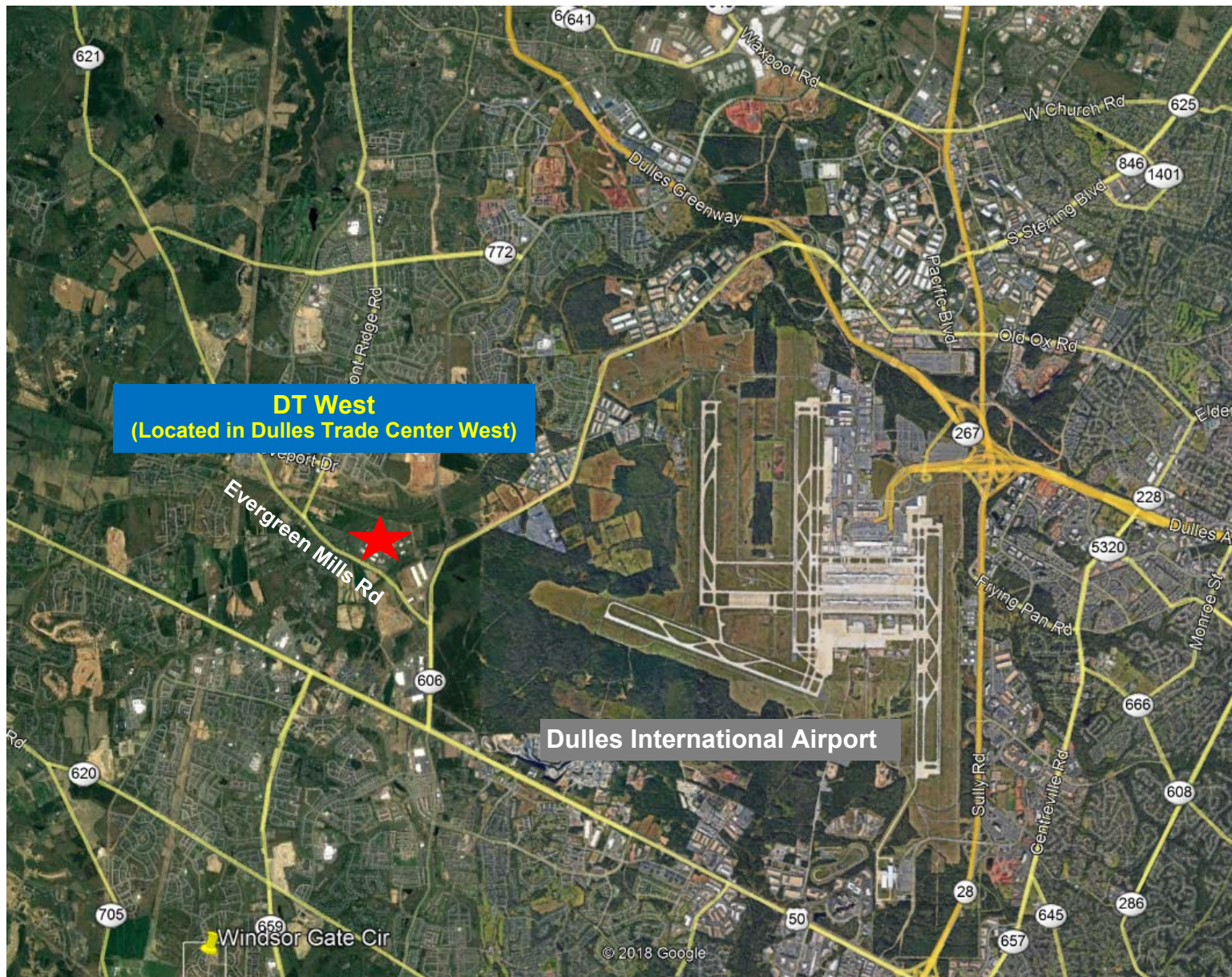
SITE PLAN
