I, Max Cook, the undersigned District Attorney of said County, in the name and by the authority, and on behalf of the State of Oklahoma, give information that in said County of Creek and in the State of Oklahoma, BEVERLY S. NOE together and in concert with Ida Mae Prewitt, did then and there unlawfully, willfully, knowingly and wrongfully commit the crime(s) of:

COUNT 1: MURDER IN THE FIRST DEGREE ~ a FELONY, on or about the 29th day of March, 1992, in Creek County, Oklahoma by unlawfully and with malice aforethought causing the death of another human being, to-wit: Wendy Camp by inflicting certain mortal wounds, to-wit: gunshot and sharp force injuries and Wendy Camp did in fact die as a result of the wounds inflicted by Beverly Noe in concert with Ida Mae Prewitt.

COUNT 2: MURDER IN THE FIRST DEGREE ~ a FELONY, on or about the 29th day of March, 1992, in Creek County, Oklahoma by unlawfully and with malice aforethought causing the death of another human being, to-wit: Lisa Kregear by inflicting certain mortal wounds, to-wit: gunshot wounds of torso and Lisa Kregear did in fact die as a result of the wounds inflicted by Beverly Noe in concert with Ida Mae Prewitt.

COUNT 3: MURDER IN THE FIRST DEGREE ~ a FELONY, on or about the 29th day of March, 1992, in Creek County, Oklahoma by unlawfully and with malice aforethought causing the death of another human being, to-wit: Cynthia Britto by inflicting certain mortal wounds, to-wit: homicidal violence by unspecified means and Cynthia Britto did in fact die as a result of the wounds inflicted by Beverly Noe in concert with Ida Mae Prewitt.

AFFIDAVIT OF PROBABLE CAUSE

Charges: **Murder, 1st Degree – three counts**

Special Agent MARTY WILSON, being duly sworn and upon his oath, states as follows:

1. Your Affiant is a Special Agent for the Oklahoma State Bureau of Investigation (OSBI), where he has been so employed since 2002. Your Affiant has had specialized training in the investigation of crimes to include homicide, shooting with intent to kill, and many other violent crimes.
2. On May 30, 1992, LEON CAMP filed a missing persons report with the Oklahoma City Police Department, in reference to his wife WENDY CAMP; WENDY'S daughter, CYNTHIA BRITTO; and LEON'S sister LISA KREGAR, who had been missing since May 29, 1992.
3. On June 4, 1992, OSBI Agent JACKIE JOHNSON conducted an interview with LEON in which he provided the following:

On May 29, 1992, WENDY, BRITTO, and KREGAR went to CHAD NOE'S residence in Shamrock, Oklahoma to visit WENDY'S son, JONATHAN NOE. CHAD was WENDY'S ex-husband. WENDY and CHAD had been in a custody dispute over WENDY'S visitation of JONATHAN. On May 29, 1992, CHAD'S mother, BEVERLY NOE, picked up WENDY, BRITTO, and KREGAR in Oklahoma City and took them to Shamrock for this visit. LEON told WENDY to call him when she arrived, and before she left Shamrock. LEON spoke with WENDY on that date at about 1340 hours via telephone. She said they had just arrived in Shamrock, and were at the convenience store. LEON spoke with

WENDY again that day at about 1640 hours. She told him she was again calling from the convenience store and they were about to head home. LEON never heard from her again. LEON provided clothing descriptions of the three missing persons as follows:

WENDY CAMP was wearing red sweat pants, red sweat shirt, a gold wedding band, a Timex watch, and white Reebok tennis shoes. She was carrying a black canvas purse containing a black wallet, her and LEON'S father's checkbook, and medical cards in WENDY'S name. She had a keychain with gadgets on it, including a Camel cigarette game.

LISA KREGAR was wearing a white and yellow striped shirt, acid washed jeans, black ankle boots, and yellow earrings. She had a dark blue cord purse with leather trim and shoulder strap.

CYNTHIA BRITTO was wearing a pink sweat shirt, light blue corduroy pants, a blue and black striped polo shirt, and Looney Toons high-top tennis shoes. She had a light blue and multicolor backpack with a florescent green logo.

4. On June 2, 1992, OSBI Agent JOHNSON conducted an interview with CHAD'S mother, BEVERLY SUE NOE (nee PREWITT), in which she provided the following:

CHAD had telephoned BEVERLY and asked her to pick up WENDY in Oklahoma City and take her to Shamrock to visit her son JONATHON. At 1130 hours on May 29, 1992, she picked up WENDY, BRITTO, and KREGAR from WENDY'S residence in Oklahoma City. BEVERLY drove them to Shamrock where they stopped at a gas station so WENDY could call LEON. CHAD arrived at the gas station, picked up WENDY, BRITTO, and KREGAR, and took them to his residence. BEVERLY; her mother, IDA PREWITT; and JONATHON followed them to CHAD'S house. WENDY and CHAD asked BEVERLY to leave so they could visit. WENDY asked her to pick them up at 1630 hours. BEVERLY and IDA picked WENDY, BRITTO, and KREGAR up from CHAD'S, and they again stopped at the gas station so WENDY could call home. They began the trip back to Oklahoma City, but IDA didn't want to listen to WENDY anymore and asked to be taken home. BEVERLY took IDA home to Bristow, Oklahoma, and then left toward Oklahoma City on Highway 66. On the way back to Oklahoma City, WENDY kept making nasty remarks and asking stupid questions, so, at about 1800 hours, she dropped WENDY, BRITTO, and KREGAR off at the Wal-Mart store in Chandler, Oklahoma, and went back to Bristow.

5. According to BEVERLY NOE'S claims, she was the last person to see CAMP, KREGAR, and BRITTO alive. The last place the three were seen alive was Shamrock, Oklahoma which is in Creek County.

6. OSBI investigation into BEVERLY'S story about dropping the girls off at the Wal-Mart store in Chandler proved fruitless. All employees working at that time were interviewed, as well as employees of neighboring businesses. Nobody saw anybody matching the descriptions of WENDY, KREGG, or BRITTO during the timeframe they were supposed to have been there.

7. On June 2, 1992, COYLA PARKS provided the following to OSBI Special Agent DAVE PAGE:

PARKS was the sister of GARY NOE, BEVERLY'S ex-husband and CHAD'S father. PARKS last saw BEVERLY about two to three weeks prior to the date of this interview at her (PARKS') house. BEVERLY stated if it came to losing JONATHON to WENDY, she would kill WENDY. PARKS learned from GARY that CHAD said BEVERLY carried a .357 caliber revolver in her purse during court proceedings concerning the custody of JONATHON.

8. On March 28, 2013, Creek County District Attorney's Investigators ANDY HOWARD and FRANK SMITH interviewed BEVERLY'S brother, GROVER PREWITT. GROVER provided the following:

In 1992, GROVER owned 40 acres of land just northwest of Teriton, Oklahoma in Pawnee County. His mother, IDA, had bought five of those 40 acres. IDA moved a trailer house onto her five acres. IDA had GROVER hire a backhoe operator to dig a hole behind her trailer for the purposes of installing a septic tank. The hole sat empty for quite some time. All of a sudden, after the three girls went missing, IDA had GROVER call the backhoe operator and had him come out and fill the hole in. GROVER never looked in the hole after the girls went missing because he was scared of what he would see. GROVER thought IDA and BEVERLY killed the missing girls. GROVER was not certain, but if he were a betting man he would bet the girls' bodies were in that hole.

GROVER showed investigators where IDA had the hole dug for the septic tank, and where he thought the girls could be buried. IDA never moved into the trailer and later sold the property. Also during this interview, GROVER turned over to investigators a sawed-off Stevens double barrel 12 gauge shotgun. This shotgun was referred to within the family as "Baby".

9. On April 2, 2013, OSBI Special Agent MARTY WILSON and Investigators HOWARD and SMITH conducted another interview of GROVER, in which GROVER provided the following:

GROVER distanced himself from his sisters and mother years ago. GROVER thought IDA and BEVERLY had something to do with the three missing girls, but did not know for sure. He did not know what had happened to them, but the only place he could think they could be was in the hole he had shown the investigators. At the conclusion of the interview, while walking out the door, GROVER shook SMITH'S hand very tightly, leaned in close to SMITH, and said, "I'm serious. You need to look in that hole."

10. On April 4, 2013, GARY NOE provided the following to Agent WILSON and Investigators HOWARD and SMITH:

GARY was the ex-husband of BEVERLY NOE and the father of CHAD NOE. BEVERLY had always wanted, and tried to get, custody of JONATHON. BEVERLY once made the comment to GARY that getting custody of JONATHON "wouldn't be a problem if that little bitch wasn't involved" – referring to WENDY CAMP. Sometime recently, BEVERLY told GARY she had gone to Church and gotten saved. GARY told her it was not possible to be saved unless you confessed all your sins. BEVERLY said she had confessed all her sins except one, and she would take that one to the grave.

11. On April 15, 2013, OSBI Agents and Creek County DA's Investigators went to the location shown to them by GROVER. This was on the property GROVER and IDA owned at the time WENDY, BRITTO, and KREGGEAR went missing. OSBI Agent WILSON obtained consent to search the location from the current property owner, and a search was begun. During this search, investigators excavated the skeletonized remains of three human bodies. Two of the bodies appeared to be adults, and the third appeared to be that of a small child. One skeleton was clothed with red sweat pants, red sweat shirt, and white tennis shoes; the second skeleton was clothed with a white and yellow striped shirt, and black ankle boots; and the child-like skeleton was clothed in a blue and black striped polo shirt and pink and white tennis shoes. During the excavation, investigators also located a pink-colored backpack with CYNTHIA BRITTO'S name written on the inside, and a black purse containing a medical card issued to WENDY CAMP. Also recovered during the excavation were what appeared to be a Ruger Security Six .357 caliber revolver and two knives which appeared to be filet type or kitchen knives.

12. On April 24, 2013, Agent WILSON and Investigators HOWARD and SMITH met with GROVER at a predetermined location in Bristow. The purpose of this meeting was to send GROVER in an undercover capacity to engage BEVERLY in conversation concerning the WENDY CAMP, CYNTHIA BRITTO, and LISA KREGGEAR homicides. GROVER was fitted with an audio digital recording/transmitting device, and an additional digital recording device was also placed in his shirt pocket.

Investigators followed GROVER to BEVERLY'S residence located at 315 E. 9th, Bristow, Oklahoma, in Creek County. Investigators monitored the audio transmitter worn by GROVER, and could hear him and BEVERLY speaking. At one point during the conversation while talking about how much their mother, IDA, liked to brag, BEVERLY was heard to say, "I told her before, more than one time, loose lips sink ships Momma. Shut your damn mouth." GROVER also told BEVERLY investigators had taken guns from his house. BEVERLY said, "Well I don't know why they'd want the guns, when she threw 'em all in there."

13. In a sworn statement given by GROVER PREWITT on July 26, 2013, GROVER provided the following:

Near the end of April 2013, GROVER saw BEVERLY at the casino in Bristow, Oklahoma. BEVERLY approached him and asked where the shotgun was – referring to the sawed-off shotgun known to everyone in the family as “Baby”. GROVER told her the OSBI had the shotgun. BEVERLY told him she was not sure whether the shotgun was used or not, but she thought it might have been used one time. GROVER told her the OSBI was after the shotgun and his .357 caliber revolver. BEVERLY told him, “You don’t have to worry about the .357 because I used EDDIE BISHOP’S .357, and they cannot tie it to me.” GROVER was certain BEVERLY said, “I’m the one that used the .357.” BEVERLY did not say anything to GROVER about who or what she was talking about, but it was his impression she was referring to the murders of WENDY CAMP, LISA KREGG, and CYNTHIA BRITTO.

Very shortly after WENDY, KREGG, and BRITTO went missing GROVER went out to his 40 acre property near Terlton to dispose of a couch. IDA was at the property when he got there. She told him she wanted the hole that had been dug for a septic tank covered up. GROVER asked her why, to which IDA responded, “Because there’s a couple of dead bodies in there.” GROVER did not ask any questions of his mother because he did not want to get involved, but he did contact a backhoe operator to fill the hole in. GROVER also sprinkled black pepper on the spot where the hole had been. IDA asked him to do that, but he did not do it right away. He sprinkled the pepper a couple of months after the hole had been filled in.

14. On January 10, 2014, Office of the Chief Medical Examiner Anthropologist ANGELA BERG reported to Agent WILSON the remains which were exhumed from the site near Terlton in April 2013 had been identified through DNA comparison as the bodies of WENDY CAMP, CYNTHIA BRITTO, and LISA KREGG.
15. On March 7, 2014, reports were released by the Office of the Chief Medical Examiner concerning the deaths of WENDY CAMP, LISA KREGG, and CYNTHIA BRITTO. Cause of death for WENDY CAMP was reported by Medical Examiner Dr. JOSHUA LANTER as gunshot and sharp force injuries. Cause of death for LISA KREGG was reported by Dr. LANTER as gunshot wounds of torso. Cause of death for CYNTHIA BRITTO was reported by Dr. LANTER as homicidal violence by unspecified means. Manner of death for all three was reported by Dr. LANTER as homicide.

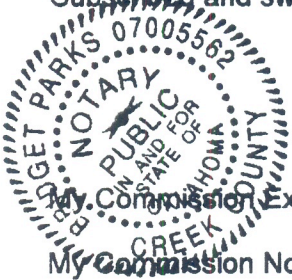
