4) **Royalties**

8) **Compensation**

Payment for this License is non-refundable.

If the Licensee fails to pay the Licensor, timely, or Does Not Complete the Payments provided for hereunder, or Does Not Perform its other obligations hereunder, including having Insufficient Bank Balance, OR Requesting a Refund or Remittal of Funds from **PayPal** or **Stripe** to Revert back to Licensee's Account and causing **PayPal** or **Stripe** to Remove Funds for This Master Recording from Licensor's Account within Anytime of the Terms of This Agreement, then the Licensor Shall Have the Right to Terminate this License upon Written Notice to the Licensee. Such Termination Shall Render the Recording, Manufacture and/or Distribution of Recordings for which monies have not been paid subject to All Actionable Infringements Under Applicable Federal & State Laws, including, without limitation, the United States Copyright Act, as amended.

9) **Indemnification.**
