



3rd Coast Labrador Retriever Rescue Foster Agreement

I, _____, having applied for and been approved as a Foster for 3rd Coast Labrador Rescue, make the following statements and voluntarily enter into this agreement to become a foster for 3rd Coast Labrador Rescue (hereinafter 3CLR). This agreement is applicable to all future foster dogs and foster situations for 3CLR:

- I understand that I could be required to provide foster care to my foster dog for an extended and indefinite period of time. I agree that the period covered by this agreement is the entire time during which I have custody of my foster dog.
- I understand that 3CLR provides no guarantee as to the health of my foster dog, and that my foster dog may have significant medical needs, socialization problems, and not be housebroken.
- I will take all necessary precautions to prevent my foster dog from either impregnating another dog or becoming impregnated. In the event that happens, I will alert 3CLR immediately.
- I will not arrange or pay for, or otherwise cause, any elective veterinary procedure to be performed on my foster dog during the period covered by this agreement, without the express written consent of 3CLR.
- I attest that I have proper insurance coverage for any dogs, mine and fosters, in my home.
- I understand that I may only have my foster dog temporarily.
- I expressly waive and hold harmless 3rd Coast Labrador Retriever Rescue, their agents, employees, officers, volunteers, and heirs from all liability for any form of loss or claim of any nature, however caused, arising out of or related in any way to damage caused by the foster dog.
- I agree that I am fostering this dog for 3CLR, and that I do not have any right of ownership over this foster dog. I further agree that 3CLR's rights in and to any foster dog are superior to mine. I also agree to provide 3CLR access to my home and property to check on my foster dog, at any time that I am in possession of my foster dog.
- I agree to immediately return any foster dog in my care to Shelter, at the request of the 3CLR at any time and for any reason. If 3CLR is forced to undertake any action to enforce this provision of the agreement, I agree to indemnify 3CLR for all court costs and attorneys' fees connected with such an action.
- If I am planning to move at any time during the period covered by this agreement, I agree to contact 3CLR prior to my move, with new contact information. I understand that 3CLR has the right to request return of my foster dog based on such a change of residence, and agree that I will surrender my foster dog to 3CLR immediately upon request.
- I understand that because the provisions of this agreement are legally binding, any violation of this agreement could result in legal liabilities for myself and 3CLR.
- If at any point I can no longer, or do not want to continue to, provide care, food, shelter or veterinary care for my foster dog, I agree to contact 3CLR, and arrange for surrender and return of my foster dog back to 3CLR.
- I will not transfer possession or custody of my foster dog to any other person at any time, except for temporary, short-term possession for the purpose of vet care, grooming, etc.

- I agree to contact 3CLR with any and all questions or concerns about my foster dog or the fostering program, as well as with updated contact information. I also agree to contact the 3CLR with weekly or monthly reports on the health status of my foster dog.
- I agree that if I refuse or fail to comply with any provision of this agreement, 3CLR has the right to terminate this agreement and also has the right to the immediate surrender and return of my foster dogs for whom I am providing foster care for 3CLR. I further consent to provide 3CLR with access to my premises if necessary to facilitate the return.
- I agree that the opportunity given to me to help rehabilitate the foster dog, as well as the chance of a potential future adoption, is of significant benefit to me, and serves as proper legal consideration in exchange for my agreements stated in this contract. I have read this Agreement in its entirety, and I agree that all statements and stated agreements contained in this document are made by me, and are truthful, under penalty of perjury under the laws of the state of Michigan.
