



## ENTERTAINMENT CONTRACT

This contract is for the personal services of **The Buzzcatz**; made this 2nd day of July 2018 between **Sofonda Corona** (hereinafter called the Purchaser) and **Ricky Sylvia** for **The Buzzcatz** (hereinafter called the Artists). The Purchaser hereby engages the Artists based on the terms and conditions below as provided for in any attachments as referred to herein.

TYPE OF EVENT: Wedding Reception

DATE OF EVENT: **March 15, 2019**

VENUE: **Interlachen Country Club - Winter Park, FL**

ARTISTS PROVIDED: The Buzzcatz - 9 piece band with Ricky

ARTISTS FEE: \$8500.00

HOURS OF EVENT: **6:00pm - 11:00pm** (*solo pianist from 6pm-7pm for cocktail hour at n/c*)

ARTIST'S ATTIRE: Formal

DEPOSIT: **A non-refundable deposit of \$4250.00 payable to Ricky Sylvia is due with a signed contract in order to confirm and reserve The Buzzcatz for this date at this rate.** The final payment of \$4250.00 is due on 3/7/19.

**IN THE EVENT OF CANCELLATION BY THE PURCHASER:** The Purchaser will provide a written notice of intent to cancel at least 60 days prior to the event, or pay the balance due to Ricky Sylvia.

**IN THE EVENT OF CANCELLATION BY THE ARTISTS:** All deposits and payments will be fully refunded and a comparable replacement artist will be recommended for the event. The only exception will be an excused non-performance (see attached rider). The Purchaser will provide stage, power, and meals for the band as outlined in the attached rider.

## **Entertainment Contract Rider /Attachment:**

**Excused Non-Performance:** The Artists shall not be liable to the purchaser for any failure, delay or interruption in the performance or any of the terms and conditions of this contract due to causes beyond our control that make the performance of this agreement either illegal, impossible or commercially impracticable, such as, but not limited to: Acts of God, war, government regulation, disaster or other casualty, acts and/or threats of terrorism, death, illness, or other events beyond the Artist's control to hold the event. The Artists may terminate their obligations under this agreement if such obligations are delayed or prevented by any of the above occurrences to the extent such incidents are beyond the Artist's reasonable control. In the event of a cancellation, the Artists will make every effort to find a comparable replacement to fulfill the engagement.

**Parking:** The purchaser will pay for or validate any parking fees imposed by the venue.

**Power:** The Purchaser will provide a power drop from the venue with four **dedicated/separated 20-amp services** run to the stage/playing area.

**Stage:** The Purchaser will provide staging or playing area of 24 ft. wide x12 ft. deep.

**Meals:** The Purchaser will provide meals, beverages with soda and coffee service and a dressing room for nine performers + two crew members.

**Load in/out:** The Artists will be set up at least thirty minutes prior to the guests arrival; unless otherwise arranged for by the purchaser. The stage will be accessible by carts with elevator access - no stairs. The stage will be clear of any decorations, podiums, and props and in ready for set up two hours prior to doors opening for setup. The stage and load out area will remain lighted by the venue for at least 1 hour following the end of the performance while The Artists load out.
