The Purchaser agrees to the following:

1. Before signing, the purchaser has reviewed, asked any questions, and understood this contract.
2. This is a legally binding contract. Legal jurisdiction required to uphold this contract will take place in the County of Placer in the State of California. If any single item on the contract is considered null and void, it shall not affect the remaining terms and conditions of the contract.
3. At no point in time may the cat be sold, leased, given away or surrendered to a shelter or rescue. If you are unable to keep the cat, you must contact Jon and Robyn who will assist you in rehoming the cat.

4. The cat is to be spayed/neutered by 12 months of age. When Jon or Robyn Paterson receives the spay/neuter certificate along with a picture of the surgery scar, you will receive the TICA registration papers. The cat is not to be bred from prior to spay/neuter.
5. The cat may not ever be declawed. If it is discovered to be declawed, it will be immediately surrendered to Jon and Robyn Paterson with shipping expenses paid by the buyer.
6. You must continue raw food for at least two weeks in order to have a smooth transition. We strongly encourage you to continue raw feeding, and we encourage you to ask us any questions to make sure you have the proper balance once you pick a food.
WE WANT YOU TO UNDERSTAND THAT IF YOU FEED KIBBLE OF ANY KIND, YOU ARE SHORTENING YOUR CAT'S LIFESPAN.

Health Guarantee

7. The cat/kitten is guaranteed to be of sound health upon arrival. It is guaranteed for a period of 72 hours from the time of receipt. It is required that the cat be quarantined during this time. If a licensed Veterinarian finds the cat not to be of sound health, the cat may be returned with a written statement signed by the licensed Veterinarian for a full refund or a replacement cat/kitten of equal value.
8. If the cat is returned under any circumstances, the purchaser will pay any associated costs in returning the cat to the seller.
9. The cat may not be given the FIP vaccine. If the FIP vaccine is administered, the Health Guarantee becomes null and void.
10. The cat is guaranteed to be clear of genetic and congenital disease including FIP for three years. If a diagnosis of a genetic or congenital disease is made within the first three years of its life, a replacement kitten of equal value will be granted. Jon or Robyn Paterson has the right to request specific tests be done prior to the replacement.
11. When a replacement is requested, the purchaser agrees to grant Jon or Robyn Paterson and the vet of her choice to full access to all veterinary records.
12. If a replacement is granted, Jon or Robyn Paterson has one year from the date of notification to produce a replacement.
13. At no point in time will Jon or Robyn Paterson be responsible for any of the vet expenses or other costs the purchaser may encounter.
