

FULL RELEASE AND ASSUMPTION OF RISK

WHEREAS, the undersigned desires to join the Florida Antique Biplane Association (FABA); and WHEREAS, the purpose and function of the FABA is to promote gatherings of like-minded aviators at public and private airstrips in order to share good will and fellowship among the members of FABA; and, WHEREAS, FABA relies on the generosity of its members who offer their homes and airfield facilities for FABA events; and, WHEREAS, such facilities are often small grass strips in residential airparks and sometimes may be challenging from which to operate; and, WHEREAS, FABA and its members wish to insulate the group's organizers and hosts from liability attendant to such events; and, WHEREAS, the undersigned is/are competent aviator(s) well aware of the inherent risks associated with flying light airplanes in and out of relatively rudimentary facilities and accept(s) those risks; and, WHEREAS, the undersigned undertake to make themselves fully aware of the challenges associated with operating in and out of such facilities, NOW, THEREFORE, as material consideration for FABA's acceptance of the undersigned as a member of FABA and as a material consideration to induce hosts to offer their homes and landing facilities to FABA members, the undersigned, for themselves, their respective spouses and passengers, and heirs and representatives, do hereby and for their executors, administrators, successors and assigns, release, acquit and forever discharge and hold harmless FABA, its respective, agents, employees, servants, and successors, and all individuals who host FABA events, together with the neighbors, homeowners' associations, airfield operators of such hosts (hereafter collectively referred to as the "Released Parties") of and from any and all claims, actions, causes of action, demands, rights, damages, costs, attorney's fees, expenses and compensation whatsoever, which the undersigned has now or which may accrue on account of or in any way growing out of or resulting from any and all transactions and relationships between the undersigned and any or all of the Released Parties, from the beginning of the world through to the date hereof, including, without limitation, aviation and ground operations associated with the FABA's use of airfields and properties contiguous therewith (hereafter, the "host airfields").

It is understood and agreed that the undersigned: (a) assumes all known and unknown risks associated with the use of host airfields; (b) undertakes to use all reasonable means and resources to familiarize the undersigned with the particularities of host airfields; (c) undertakes to ensure that the aircraft the undersigned utilizes in such endeavors is safe for flight and for the particular limitations of host airfields; and (d) agrees to indemnify and hold the Released Parties harmless with respect to any claim by the undersigned and any third party whomsoever arising from any injury or damage arising from the undersigned's attendance at any FABA event.

It is specifically understood that, despite its best efforts, FABA has been unable to secure satisfactory insurance coverage for its events and to protect the released Parties and that securing this Release represents an essential consideration for the FABA to continue its activities.

The undersigned further declares and represents that no promise, inducement or agreement not herein expressed has been made to the undersigned and that this release contains the entire agreement between the parties hereto, and that the terms of this release are contractual and not merely recitals.

THE UNDERSIGNED HAS READ THE FOREGOING RELEASE AND FULLY UNDERSTANDS.
