



## HittzVille Lean

### BEATS EXCLUSIVE LICENSE AGREEMENT

YOU MUST READ AND UNDERSTAND THE TERMS OF THIS CONTRACT BEFORE YOU ENTER INTO THIS AGREEMENT. PLEASE READ IT CAREFULLY.

The following serves as a legally binding agreement between HittzVille Lean ("Licensor") and You ("Licensee"). This agreement grants the Licensee certain Exclusive rights to the instrumental(s) being licensed. All licenses are non-refundable and non-transferable.

- 1 **Payment:** The Licensee agrees to pay the Licensor a non-refundable fee of \$150 for the Exclusive use of the Instrumental(s) that is being licensed in this Agreement, for the purpose of creating a new composition.
- 2 **Publishing:** Licensee, owns 50% of publishing rights of Master Recording. Licensor, owns 50% of publishing rights of Master Recording. Any other agreement would be in writing before the Sound Recording/BEATS would be published.
- 3 **Rights of usage:** The Licensor hereby grants to Licensee an exclusive license to use Master Recording in the reproduction, duplication, manufacture, and distribution of phonograph records, cassette tapes, compact disk, digital downloads, other miscellaneous audio and digital recordings, and any lifts and versions thereof (collectively, the "Recordings", and individually, a "Recordings") worldwide for unlimited copies of such Recordings or any combination of such Recordings.
- 4 **Performance Rights:** The Licensor here by grants to Licensee an exclusive license to use the Master Recording in unlimited for-profit performances, shows, or concerts.
- 5 **Broadcast Rights:** The Licensor hereby grants to Licensee an exclusive license to broadcast or air the Master Recording in unlimited amounts of radio stations.
- 6 **Master Recording:** The Licensor hereby grants to Licensee an exclusive license (this License) to record vocal synchronization to the Composition partly or in its entirety and substantially in its original form.
- 7 **Ownership Rights:** Licensor retains 100% rights in and to the Instrumental(s) including all rights in and to the underlying composition(s). Licensee shall not sell or license the rights to the Instrumental(s) whether in whole or part to any other party.

- 8 **Producer Credit:** Licensee shall acknowledge the original authorship of the Composition appropriately and reasonably in all media and performance formats under the name of the Licensor in writing where possible and vocally otherwise. The credit shall be in the form: "Produced by HittzVille Lean"
- 9 **Sample Clearances:** Licensee is hereby notified that the Instrumental(s) may contain samples. The Licensee shall be responsible for clearing all samples. Licensor shall not be liable for the use of any sampled material by Licensee in any new composition(s).
- 10 **Indemnification:** Accordingly, Licensee agrees to indemnify and hold Licensor harmless from and against any and all claims, losses, damages, costs, expenses, including, without limitation, reasonable attorney's fees, arising of or resulting from a claimed breach of any of Licensee's representations, warranties or agreements hereunder.
- 11 **Miscellaneous:** This license is non-transferable and is limited to the Composition specified above.

If the Licensee fails to pay the Licensor, timely complete the payments provided for hereunder, or perform its other obligations hereunder, including having insufficient bank balance, the licensor shall have the right to terminate License upon written notice to the Licensee. Such termination shall render the recording, manufacture and/or distribution of Recordings for which monies have not been paid subject to and actionable infringements under applicable law, including, without limitation, the United States Copyright Act, as amended.

You further agree that any breach of this contract shall result in the revocation of the Exclusive license and termination of this agreement. Violation of the terms of this agreement may constitute a violation of copyright law.

It is each party's responsibility to notify one another of any contact information changes within 6 months.
