This Agreement is entered into between Lori A. Eby d/b/a My Dog Training For Human Companions, LLC, (hereinafter, "MDTFHC") and the Client as indicated by submission of this form. This agreement will cover all activities attended by the Client during the 2021 calendar year including but not limited to group classes, private lessons, workshops, practices, fun matches, sanctioned trials, and specialty events as offered by MDTFHC.

**Assumption of Risk:**

I understand that the dog-training activities (hereinafter, "Activities") in which I will engage with my dog at or near the training facility at 4000 62<sup>nd</sup> Ave SW, Great Falls, MT (the Barn), and in various public locations, may involve inherent and other risks. Some of those risks are described in this Agreement and are incorporated herein by reference. I hereby assume all risks and accept responsibility for any property damage and loss, and for any and all personal injury, illness (including Covid-19), disability, or emotional distress that I or my dog may suffer, or cause to any third party or real property, whether herein specifically described or not.

**Release:**

I agree to forever release and discharge MDTFHC from any and all liability or claims I may have for any property damage and loss, personal injury, emotional distress, illness or disability, including any illness or injury to my dog, related to my and/or my dog's participation in the Activities or use of any equipment or facilities.

**Indemnity:**

I agree to indemnify MDTFHC, and hold MDTFHC, harmless from all claims, causes of action, liability, losses, or damages for any property damage, property loss or theft, personal injury, disability, or other loss brought by or on behalf of me, a family member, my estate, another participant or spectator, or any other person arising from or relating to my use of the property, facilities, and/or participation in the Activities, including claims that Lori A. Eby and/or My Dog Training For Human Companions, LLC was negligent.

**Acknowledgement of Policies and Photo Waiver:**

1. I acknowledge reading and understanding the MDTFHC Release relating to the activities, facilities used by MDTFHC and equipment, and agree to comply with and abide by those Class Guidelines.
2. Lori A. Eby may take and use photographs, video, film and other images of me and/or my dog participating in or observing the Activities. I waive any right of privacy, publicity, compensation, copyright or other rights to those images and I consent to Lori A. Eby using those images for purposes solely related to MDTFHC and its associated websites.

**Volunteer Agreement**

I may, of my own free will, decide to volunteer my time at various events organized, sponsored, or hosted by MDTFHC. I understand that I will donate my time and services without any compensation and shall at no time be considered an employee or independent contractor of MDTFHC. I know of no reason, medical or otherwise, that would prevent me from performing the tasks required to participate in this volunteer activity. I assume all risks of participating in this volunteer activity and full responsibility for my conduct and actions, including any injury to myself or other or damage to property that may results while volunteering and I understand that MDTFHC is not responsible for conditions that I create myself or those created by other volunteers or participants. I understand there are risks while working around dogs and I accept those risks.

**Additional Provisions:**

I agree that the substantive laws of Montana shall govern this Agreement. Any mediation, suit, or proceeding will be entered into only in Great Falls, Montana - Cascade County. Any portion of this Agreement deemed unlawful or unenforceable is severable and shall be stricken without effect on the enforceability of the remaining provisions.

I have read this Agreement, understand its contents, and I sign it voluntarily. I intend by this Agreement to assume all hazards and risks, waive all rights to sue and release all liabilities and claims, and indemnify MDTFHC, for any claims arising from my and/or my dog's participation in the Activities.
