This contract for the breeding season of 20____, is made and entered into on this _____ day of _____, 20____, between Rocking R Ranch (referred to as Stallion Owner) and _____ (referred to as Mare Owner). Mare owner agrees to breed mare _____ Reg # _____ to Stallion Haidas Smoothie, Reg # 4728137 via breeding method (check one):

____ Cooled shipped semen for artificial insemination by Mare Owner's veterinarian in _____, ____

____ On-site live cover hand-breeding at stallion owner's facility in Miami, MB

This contract shall be subject to the following conditions:

1. The Stallion Service fee is \$_____ which includes a non-refundable booking fee of \$_____, which is payable when this contract is signed and is deducted from the stud fee. The remainder must be paid before the shipment of semen or when the mare is picked up from the collection facility. Cheques are to be made payable to Ron Rothwell.
2. The \$_____ shipped semen fees are all inclusive and include the collection and the chute fees for the first shipment. Subsequent collections will be \$_____ if required. All shipping fees are at the Mare owner's expense and will be \$_____ to be pre-paid.
3. The Artificial Insemination fee is \$_____ for insemination at the semen collection facility. The off-site mare care fee is \$_____ per day (wet) or \$_____ per day (dry).
4. When shipping semen, the Stallion owner assumes responsibility only to have the semen delivered in a viable condition at the time of delivery to the Mare Owner. The Stallion owner agrees to ship a maximum of three shipments of live semen in a viable condition per breeding year. Fees on second and third collection will be: Collection \$_____ and Shipping \$_____ each.
5. Alternatively, for live cover hand-breeding, the on-site mare care fee is \$_____ per day (wet) or \$_____ per day (dry).
6. The Mare Owner assumes responsibility that the mare will be healthy and in sound breeding condition, free from infectious, contagious and transmittable diseases and agrees to provide a Veterinary Health Certificate. The Collection facility reserves the right to refuse the mare if not in satisfactory condition. The Mare must be halter broke to be accepted.
7. The Mare Owner assumes no responsibility for injury, disease, sickness, or death to the stallion and the Stallion Owner or Collection facility assumes no responsibility for injury, disease, sickness, or death to the Mare.
8. The Mare Owner holds responsibility that the mare will be pregnancy checked at 30 days by a veterinarian. If the mare is found to be open, the Stallion Owner must be notified (by Veterinarian Certificate if a second or third shipment is to be shipped to the Mare Owner) within 7 days to make arrangement for re-breeding at the collection facility or shipment of semen.

9. Live foal guarantee. A live foal is described as a new foal that stands and nurses. It is understood that if the mare proves barren, aborts her foal or if the foal is still-born, a return breeding will be granted for the following year breeding season only, provided notification is given. Acceptable notification shall be defined as follows: written notification by a licensed veterinarian within seven (7) days that the mare is barren, has aborted or produced a non-viable foal. The Mare Owner agrees to pay a second Booking fee of \$_____ for each additional stallion collection service and the applicable shipping fee.
10. It is agreed that should the above named stallion die or become unfit for service during the 20__ breeding season, the stud fee will be refunded, thereby cancelling this contract. If the above named Mare dies or becomes unfit to breed during the 20__ breeding season, the mare owner may substitute another Mare with the agreement of the Stallion Owner. No refunds otherwise.
11. A breeder's certificate will be issued to the mare owner after all the expenses have been paid in full and notification of foal birth has been received by Stallion Owner.
12. The above Stallion is said to be EVA negative and has been vaccinated. A copy of said report is available upon request.
13. A finance charge of 1.5% of the unpaid balance will be charged on all balances remaining due past thirty (30) days.
14. This contract is non-assignable and non-transferable.
15. This contract represents the entire agreement between the parties. No other agreement promise, verbal or implied, is included. The original contract will be kept on file with the Rocking R Ranch and a copy provided to the Mare Owner. When the Mare Owner and the Stallion Owner have signed this contract, it will be binding on both parties, subject to the above conditions.
