I (we) agree that the club holding this event has the right to refuse this entry for cause which the club shall deem sufficient. I (we) certify and represent that the dog entered is not a hazard to persons or other dogs. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim, and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog. NOTICE COVID-19 Liability Waiver

The novel coronavirus, Coronavirus/COVID-19, has been declared a worldwide pandemic by the World Health Organization. Coronavirus/COVID-19 is extremely contagious and is believed to be spread mainly from person-to-person contact. As a result, federal, state and local governments and health agencies recommend social distancing and limiting the number of persons allowed to gather. NWLSSC has put in place preventative measures to reduce the spread of Coronavirus/COVID-19 for all of their dog trials, including participation as an exhibitor or volunteer. However, the NWLSSC is unable to guarantee that you, your dog, or your family will not be exposed to or become infected with Coronavirus/COVID-19 while attending the NWLSSC trial. Further participating in the NWLSSC trial could increase your risk and your dog(s)'s risk of contracting Coronavirus/COVID-19.

By signing this agreement, I acknowledge that I have read the above Notice and understand the contagious nature of Coronavirus/COVID-19 and voluntarily agree to assume the risk that I or my dog may be exposed to or infected with Coronavirus/COVID-19 by attending this trial and that such exposure or infection may result in personal injury, illness, permanent disability, and death. I understand that the risk of becoming exposed to or affected by Coronavirus/COVID-19 may result from my own actions, omissions, or negligence, or those of others, including but not limited to NWLSSC members, NWLSSC Board Members, Trial Committee members, volunteers, exhibitors, and their families.

With full knowledge and appreciation of the risks set out above, I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury or illness to my dog(s), or myself (including, but not limited to, personal injury, disability, and death) arising out of or relating to Coronavirus/COVID-19 exposure or infection that I, or my dog(s) may experience or incur in connection with our physical presence at the NWLSSC trial. I hereby release, discharge, and hold harmless, NWLSSC, its Board Members, its Trial Committee, members, volunteers, agents, and representatives; Saline County Fairgrounds, its agents and representatives; and the American Kennel Club, its Board of Directors, employees, agents, and representatives, of any and all claims (including but not limited to claims of liability and damages) of any kind arising out of voluntary participation and presence at NWLSSC's trials. I further agree to defend and indemnify the released parties for any and all claims brought by a third party that arise from my or my dog's attendance at the NWLSSC trial as it relates to Coronavirus/COVID-19. I understand and agree that this release includes any claims based on the actions and omissions of NWLSSC its Board Members, Trial Committee, members, volunteers, agents, and representatives, whether Coronavirus/COVID-19 exposure/infection occurs before, during, or after being at the NWLSSC trial.
