# Financial Request Committee- Norris Berg, chair

Danita Doerre headed up the committee during Norris' absence Three requests were granted for approximately \$650 [note: See May 2017 minutes]

Requests that have come in for upcoming year include MN state Fair ribbons; Farm Tech days at U of M; and Badgerland.

## Youth Grant Committee- Lorraine Kilmartin, chair

Two grants were awarded, but one event was cancelled. \$400 went to the Midwest Lama Club for a judging clinic and a youth clinic on June 3 at the Benton County Fairgrounds. Cheryl Pflipsen gave highlights, recapping her article from the Summer/Fall 2017 Newsletter. The application deadline for grants is March 15; information on how to apply is found on the website.

A third committee member is needed. One phone conference is usually all that is required of committee members. No one volunteered.

## Scholarship Committee- Kim Schechinger, committee co-chair

A scholarship of \$250 was awarded to Emily Billings. The second person awarded a scholarship of \$250 hasn't responded yet. The applicants have been good, qualified applicants who provided transcripts.

# Conference Fees- Kim Schechinger

With the current fee of \$25, the Youth Conference doesn't pay for itself; this year the youth were included in the banquet, and the meal cost alone was \$30. MWLA provided a budget of \$125; some supplies were donated. The youth received 8 hours of programming, including making clay ornaments, dyeing t-shirts, a movie, and more.

The board proposes raising the Youth Conference fee to \$30 to cover the cost of meals.

Discussion touched on the importance of the program, and the needs of older youth attending. Some members felt the fee was low.

Norris Berg made a motion to keep prices the same, that is, \$60 for adults; \$25 for youth; Floyd Zopfi seconded it. Motion carried with 15 Ayes and 10 Nays.

## Youth Conference Committee- Kim Schechinger

The board proposes a Youth Committee of adults and youth to help plan the Youth Conference in 2019.

Katie Mazac, Nick Hauptly, Kristie Brown (on sign-up sheet) volunteered as adult members, with Patty Patterson as an alternate; Kylie Stafford, Isaac Beck volunteered as youth members.

The committee's role would be similar to the board's role regarding the adult conference. The board would approve plans and budgets.

Lorraine Kilmartin made a motion to create a youth committee to plan the youth conference, to work with the volunteers who would May, 2017 Page 3

implement it; and to integrate it with adult conference; Nick Hauptly seconded it.

Motion carried.

# University of MN Ag Awareness Day- Julie Mazac

Julie, Connor Cook and Rick Carlson attended last year. The display with fiber and llamas received much interest from the public. 2018 Ag Awareness Day: April 10<sup>th</sup>, 10-3 pm.

# Show Superintendent Workshop- Nick Hauptly

Nick proposed a workshop to train show superintendents, to be led by experienced superintendents Kathy Duvall and Sharon Lambert. They will offer this training in their area at an SSLA conference this year, and they have background in both ILR and ALSA shows. Nick believes the Iowa Lama Association (ILA) will split the cost with MWLA. Estimated budget is \$2500 for leaders' fees and transportation. Nick suggests a donation of \$20-25 per participant for a day-long event. Discussion touched on the need for trained superintendents, the opinion that people may not be volunteering to help at shows because of a lack of knowledge, and a suggestion that a county fairground location would make it affordable. Julie Hendrikson offered that Mower County would provide the food.

Lorraine Kilmartin made a motion to share costs with ILA to bring these two speakers; to charge a fee with any excess to be split between IA and MWLA; with a maximum MWLA contribution of \$1250. Katie seconded it.

Motion carried with 1 abstention, 1 nay.

## ILR Judging Clinic- Nick Hauptly

Nick Hauptley, Katie Mazac, and Lyn Meany proposed an ILR judging clinic to be held at the St. Paul U of M Campus. Preferred dates would be in November, Friday through Saturday, but possibly in December or January. It would be a three-day clinic for those seeking a certificate at a rate of \$125 per day, and a two-day clinic for those auditing, at a cost of \$75 per day. It would include a wide range of topics. Three judges would teach the clinic. The cost for the arena would be \$7000. They expect 25-30 participants. The cost would be split with Iowa Lama Association. Nick, Katie and Lyn requested funds to reserve the facility, with a maximum of \$1000.

Discussion included pros and cons of the proposed location, a suggestion to look for farm backing for funds, and plans to reach out to organizations nation-wide via social media

A motion was made to partner with the ILA to sponsor an ILR judging clinic by providing a maximum of \$1500 with excess funds after fees to be split by the two organizations. Connor Cook seconded it. Motion carried with 3 nays.

# Llamapalooza

The board has pulled the show together for May 12-13, 2018 at Shepherd's Harvest, Lake Elmo, MN; there is a welcoming letter in the conference packet; Dan Whittaker will put the information online. Mike Haumschild will judge. Tracey McGinnis has put in the application for sanction fee. Jenni, Pat and Eric Olson will handle the registration and ILR work, and they have ordered ribbons. Information should be live on ILR soon if it is not already. Delivery of gates and obstacles has been arranged. Ann Barkly will clerk. Rooms are blocked under "Midwest Lama Association" until April 11 at Country Inn and Suites in Woodbury (10 rooms, at \$89) and at Holiday Inn Express Woodbury (at \$126, more with breakfast). Hotels in Hudson are another option. Volunteers are needed at the show.
