

# Robbi K & Friends - Osebo's Drum - Tech Rider

**Stage:** A stage of at least twenty-two feet (22') in width, by sixteen feet (16') in depth, by two feet (2') high. Robbi must have access on and off stage into the audience; steps/stairs stage center, right stage or left are required to enter and exit, as well as mandatory crossover. ## Lighting:

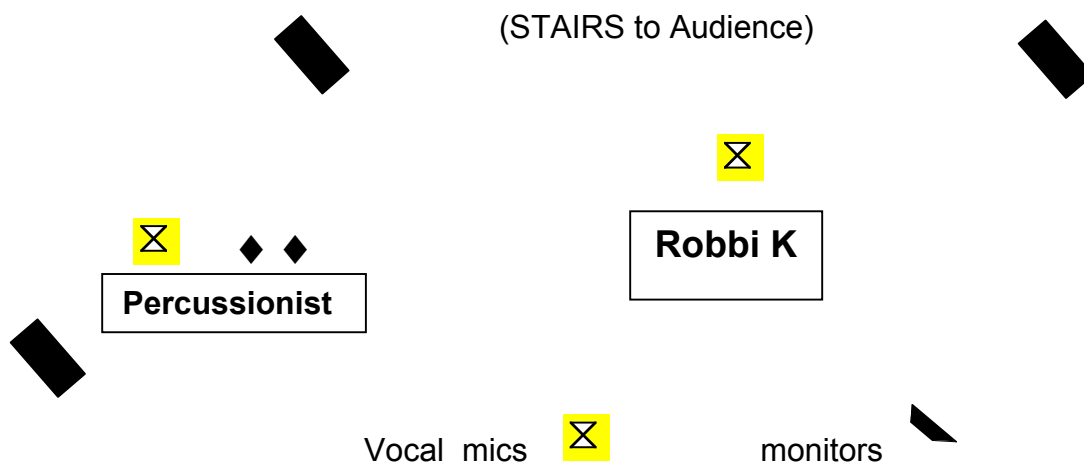
- A full blue wash of the entire stage - moderate to low density
- A red wash of the stage left - moderate
- A stage right area - neutral or amber
- A stage center area - neutral or amber
- A stage left area - neutral or amber
- A follow spot

Lighting Cue Sheet available upon request.

A non-theatrical lighting system must allow at the very least for the following:

- The ability to illuminate the entire stage
- The ability to darken the house (seating area) to full black
- The ability to produce slow fades and rapid blackouts

- 1 handheld, headset, or lavalier wireless mic (Shure or Sennehiser)
- 1 SM 58 Beta for Percussionist vocals
- 1 Goose Neck Instrument Mic
- 1 Djembe drum mic
- 3 monitor wedges
- 4 Music Stands
- 1 Short Stool

# Robbi K & Friends - Osebo's Drum - Tech Rider

**Local crew and sound check:** The performance space must be technically prepared and available exclusively to Robbi Hall Kumalo and Hasan Bakr for a technical check and dress rehearsal for a length of up to 1.5 hours.

Sufficient personnel shall be present to assist in the technical check, and if needed make adjustments. Said personnel must remain present on the premises until the technical rehearsal has been completed.

**Lodging and ground transportation:** PURCHASER is to provide lodging including 2 single, 3 star hotel rooms in a safe, clean, location near to venue. If the ARTISTS are coming by plane, a comfortable, clean car should meet ARTISTS and all ground transportation between venue, hotel & airport to be provided by PURCHASER.

**Hospitality:** *On Stage:* 4 large hand towels (black) & room temp bottled water. *Dressing Room/Backstage:* dressing room with a coat-rack including hangers, electric Iron and board, sofa or large chairs, and a full-length mirror: Chilled bottled water, juices (Pomegranate and Grapefruit), fresh, seasonal fruits & veggies.

**Merchandising:** ARTIST shall have exclusive merchandising rights, including without limitation the right to sell or cause to be sold posters, t-shirts, programs, CD's or any other items of any kind during the engagement. Any variations from this must be discussed with Bali Dali Productions prior to the engagement.

**Taxes:** If you are required by state law to withhold any taxes from the fee, please state this on the face of the agreement and notify Bali Dali Productions in no case later than 90 days prior to your performance date so that we may explore the possibility of having them reduced or waived. The PURCHASER shall pay and hold ARTIST harmless of and from all licensing fees and amusement taxes directly related to stated performance only.

**Recording/taping requirements:** ARTIST shall have the sole and exclusive right to film, record, tape or otherwise reproduce and embody, any and all performances by ARTIST, including without limitation audio tape, visual tape and any other audio-visual process or solely visual process. No other recording, filming or taping of this performance here under will be permitted without ARTISTS prior written permission.

Concerning TELEVISION, any requests MUST be made directly to the ARTIST.

**Insurance:** PURCHASER agrees to indemnify and save harmless Robbi Kumalo and its servants or agents from any and all claims, liabilities, loss, demands or actions whatsoever for any personal injuries, death or property damages to any persons attending the affair hereby contracted for and any reason or cause whatsoever. Venue agrees to procure and continue in effect a comprehensive general liability insurance policy naming the ARTIST as insured with respect to personal injury and property damage liability arising in any manner in connection with the performance, with minimum liability limits of \$1,000,000 per occurrence for personal injury or death and \$250,000 for property damage in any one occurrence. At the request of the ARTIST, VENUE will furnish ARTIST with a certificate or certificates evidencing such coverage.

**Addendum Adherence, and Dissemination:** No deletions, additions, or substitutions to this document will be accepted unless counter-initialed by BaliDali Productions Inc. A contact sheet will be provided closer to performance date.
