## Chef's Corner

### Archie Squares

2 1/2 cups Whole Wheat Flour

1/2 cup Powdered Dry Milk

1/2 tsp. Garlic Powder

1tsp. Brown Sugar or Honey

6 tbs. Meat or Bacon drippings, cold right from refrigerator, not melted or soft!

1 Egg, slightly beaten

1/2 cup Ice Water

Pre-heat oven to 350 degrees. Lightly oil a cookie sheet. Combine flour, dry milk, garlic powder and sugar. Cut in

meat drippings until mixture resembles corn meal. Mix in egg. Add enough water so that mixture forms ball. Using your fingers, pat out dough onto cookie sheet to 1/2" inch thick. Cut dough into squares appropriate for your dogs size. Prick each cookie with fork. Bake 25-30 minutes. Remove from tray and cool on rack.

Store in airtight container.
