

NOTICE TO EXHIBITORS

- * The safety of the dogs is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely.
- * Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the show committee.
- * It is expressly understood that exhibitors alone are responsible for the behavior of their dog(s) and / or children. Any exhibitor whose dog(s) and / or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the show committee, be asked to leave the show site. In that case, no refund of any fees paid will be made.
- * No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee.
- * Exhibitors are responsible for complete, accurate, and legible information on the entry forms: illegible or incomplete entries cannot be entered in the show.

From I-78 North and points East or West: Take the PA-29 S exit- EXIT #55- toward EMMAUS, turn slightly right onto S CEDAR CREST BLVD / PA-29. Follow Route 29 south for approximately 9.5 miles then merge onto Route 100 south. After 3.7 miles you will see Longacres Electrical Supplies on your left, you make a right there onto North Church Street. *Obey the speed limit in this area or you will be ticketed, continue straight onto Crow Hill Road up a hill to Belle Vista Lane on your left just past a small pond. You can see the white building on top of the hill.

From Philadelphia and points South East: I-76 W toward VALLEY FORGE, take the US-202 S / US-202 N / US-422 W exit- EXIT 328B-A- toward WEST CHESTER / KING OF PRUSSIA / POTTSTOWN / SWEDES FORD RD. Merge onto US-422 W for 21.9 miles then take the PA-100 N exit toward ALLENTOWN for about 12.5 miles. You will see Longacres Electrical Supply on your right, make a left onto North Church Street and follow directions above *

Pa Turnpike- NE Extension to Quakertown Exit bear right onto Route 663 South. As you enter Pennsburg you will make a right onto Route 29 North. Follow Route 29 to the town of Hereford (Turkey Hill and Light) Turn Left onto Route 100 South and follow into Barto, you will see Longacres Electrical Supplies on your left, you make a right there onto North Church Street. *Obey the speed limit in this area or you will be ticketed, continue straight onto Crow Hill Road up a hill to Belle Vista Lane on your left just past a small pond. THERE WILL BE NO MEASURING OF DOGS AFTER JUDGE'S BRIEFING BEGINS EACH DAY - ALL DOGS WITHOUT A PERMANENT CARD MUST BE MEASURED BEFORE THE JUDGES BRIEFING TO SHOW THAT DAY - THERE WILL BE NO EXCEPTIONS

PRIZES & AWARDS: Placement rosettes or ribbons will be awarded for 1st through 4th place for Qualifying and non-qualifying scores for all classes. Dogs with an NT (no time) are not eligible for any ribbons. Qualifying ribbons will be awarded to all dogs receiving a qualifying score, and Jr Handlers in Standard.

EXERCISE YOUR DOG RESPONSIBLY! PLEASE PICK UP AFTER YOUR DOG AT THE SHOW SITE AND HOTELS! ALL DOGS MUST BE ON LEASH EXCEPT WHEN IN THE RING OR WARM UP AREA. THERE IS A LEASH LAW IN THE TRIAL SITE'S STATE.

OBSTACLES: The following obstacles may be used. Obstacle specifications shall meet the current CPE obstacle requirements

Aframe – 9' sides, rubber granules, slats	Dog Walk – 12' planks, rubber granules, slats
Teeter – 12' plank, rubber granules, slatless	Weave poles – 24" poles - center to center
Jumps: Bar, Spread, Panel	Open Tunnels

We now have an online form for volunteer sign-up. The link will be included in the final confirmation email that will go out 7-10 days before the trial. During the trial, we need gate stewards, timers, scribes, bar setters, leash runners, scribe sheet runners, and course builders. Can't access the form, no problem as you can always sign up at the trial. Workers get entered in a raffle for credits toward future entries! Don't worry if you don't know how to do a job! They are easy and we can show you how!

Saturday December 15 will be Ugly Sweater Day.

3D Dog Training Top Dog 2018 Award

3D Dog Training will be offering an embroidered chair to the winner of our Top Dog in 2018. This competition will be for all runs at 3D Dog Training LLC CPE trials from January 13, 2018 to December 16, 2018 and the prize will be given out at our January 2019 CPE trial. The dog does not need to run at all our trials or in every run at every trial. The winner will be the dog with the most CPE Q-points earned at our trials. If there is a tie the first tie breaker will be the most FullHouse game points earned at those trials, then Jackpot game points earned at those trials, then Snooker points earned at those trials, then total Colors Q's. If there is still a tie the dog with the fastest qualifying time in the last FullHouse class of the year wins. All club decisions are final!

There is a \$25.00 service fee in addition to any bank fees for returned checks!

CPE trial rules – shortened version: see the online rulebook at www.k9cpe.com for registration info, “Registering with CPE” and further info on height categories and rules.

Jump Heights – no dog will jump lower than 4”

P-Card = Permanent Card: the lowest allowable Regular height a dog may jump in CPE.

General CPE rules for entries/show site:

- Dogs must be at least 15 months or older the first day of the trial
- Blind (both eyes), lame, in season or aggressive dogs may not enter the show. The Club may choose to exclude any of the above from the site.
- Dogs must be registered with CPE prior to the closing date of the trial, or by the trial date for Day of Show entries. Registration forms are on the Forms page: www.k9cpe.com. Forms MUST be mailed to CPE and are processed 2-3 times per week. CPE ID numbers are emailed to legible email addresses. Registrations can only be processed from mailed forms.
- Dogs must be able to be measured at their first show. If a dog cannot be measured, the dog cannot run and no refund will be issued. Dogs within ½” of a jump height require at least one more measurement. When dogs reach their second birthday, a measurement is required. All dogs must be measured at their first trial regardless of jump height.
- Only CPE Judges can measure dogs.
- Electronic shock collars are not allowed at ANY CPE trial – training or bark.
- Handlers in all classes are permitted to walk the course, without a dog, prior to the start of the class. A warm-up jump shall be provided for all entered dogs. No relieving of dogs in the warm-up area.

Dogs in the ring, leashes, exiting the ring

- Dogs shall run without anything attached to its body. This is for the safety of the dog. This includes no: collars, stitches, wraps or any other item. The only exception is a small barrette or rubber band to keep hair out of a dog’s eyes.
- Leashes may not have anything (other than name/license tags) attached to them when used in the ring.
- Dogs may enter the ring on a collar, quick release harness or head halti/leader. If prong collars are allowed per the show site, they may *not* be used to take a dog into the ring.
- Handlers may not carry their leash with them on the course – if done so, an NT will result. Exception: Handicapped handlers that have a mobility

problem in picking up the leash at the finish may put their leash in their pocket – the leash must be out of sight.

- Dogs must be under the handler’s control when leaving the ring or the judge may enter the run as No Time - NT.

Training a dog in the ring during a run

There is no training in the ring at a CPE agility trial. First offense will result in an excusal from the run. Further offenses will result in additional excusals for the day/weekend per the judge’s discretion. This is for the safety of the dog.

The following items *are not* considered training in the ring (also see FEO):

- Dog grabbing it’s leash at the end of a run (if the run has not yet ended, the dog would receive an NT)
- Asking the dog once for a sit or down on the table in the point games (asking more than once will be a delay of finish, 5 faults/points)

The following items *are* considered training in the ring:

- Violating the 4 paw safety rule (directing the dog back onto the contact)
- Start line stay – leaving the dog and going back again to reposition the dog after the handler passes the plane of the first obstacle (before the handler leaves the dog, repositioning or repeated commands can be a delay of start)
- Putting the dog back on the table in the point games

While running on course

- The handler will direct the dog through the course without a collar or lead.
- Food, toys, training devices (includes fanny packs and leash attachments) are not allowed within 10’ feet of the ring. Clickers, training whistles and squeaky toys are not to be used within distraction distance of the ring.
- The handler may not carry anything that could aid the dog in its performance. Exclusion: Handicapped/Differently Abled Handlers using a cane, scooter, wheelchair, etc., to enable their progression around the course.

The handler may use any verbal or visual commands to direct the dog through the course. The Judge may assess a 5 fault penalty to elimination for any command that is not given in a sportsmanlike manner. Faults can be, but are not limited to: foul or abusive language, display of anger, extreme frustration or excessive harshness. If the fault is severe enough, the Judge has the right to excuse the exhibitor from the ring and / or the remainder of the trial. If excused from the trial, a report would be filed with CPE. See Faults, Eliminations and Excusals in the rulebook.

This also includes if there was a correction to a scribe sheet – the handler must verify that the results were corrected as well.
