I, _____ here after referred to as the adopter, hereby agree that the above described dog is being adopted by me solely as a companion for myself and/or my immediate family. I agree that I will not sell, give away or otherwise dispose of said dog to any

person(s), dealer, retailer, auction, institute or any other entity for any reason. If at a later date I am unable or unwilling to keep this dog, I agree to first contact Outback GSP and give them the option to reclaim the dog at no charge.

I hereby agree to care for the above named dog in a humane and responsible manner and to provide it with clean and adequate shelter, food, water, exercise, and veterinary care. I further agree that said dog reside inside my home or in a fully contained yard or kennel and shall not be permitted to roam freely. If in a kennel, the living quarters should be adequate for the dog to be protected from climate and weather. Additionally, if the dog is contained in a kennel, I agree to provide ample time allowed for daily exercise. I also agree to keep the dog's kennel clean and without built up urine and feces.

I hereby agree that Outback GSP makes no guarantees the dog will hunt. I understand Outback GSP will let adopter know of the named dog's level of training up front, but no guarantee will be made on the named dog's skills and abilities.

I hereby agree that this dog shall wear a collar or harness with identification tags at all times.

I hereby agree to only feed a high quality kibble or a raw diet to the named dog. This means brands such as (but not limited to) Ol Roy, Purina, Gravy Train, Twin Pet – and mostly any brand found at grocery stores are considered LOW QUALITY KIBBLE and will not be fed. I understand that if I am unsure of kibble quality or where to purchase a quality kibble, I may contact Outback GSP for advice.

I hereby agree that the adoption fee of \$300 helps to cover Outback GSP's expense of surgical sterilization and veterinarian wellness exam and is not refundable.

I hereby understand and agree that Outback GSP makes no representations or warranties, expressed or implied, about the above mentioned animal's temperament or long term health and is hereby absolved from any liability for future damages or injuries caused by said dog. I also understand and agree that Outback German Shorthaired Pointers further gives no guarantees, expressed or implied, of the suitability of the dog to the adopter and/or the adopter's immediate family.

If Outback GSP feels that the named dog is being neglected, abused, is involved in unethical activities, or can no longer be cared for – Outback German Shorthaired Pointers reserves the right to take repossession of the dog from the named adopter (willingly or unwillingly), and will exercise this policy In Full with assistance from Law Enforcement and/or Civil Court.

I certify that all statements made by me on this adoption agreement are true and correct. I agree that Outback GSP has the right to confiscate the above named dog in the event that any statements made by me are found to be false and/or my payment for the adoption fee is returned for insufficient funds or is disputed/charged back.
