SUBMISSION REQUIREMENTS

For consideration of inclusion, please digitally submit the following:

- A photo of the chair
- Approximate dimensions and weight
- Short description or history of the chair

Chairs must be available for display for the entire exhibition, and ready for professional display.

Please submit all requested information to info@hammondarts.org by 3/20/20 with the subject title THE CHAIR. The jurors of this exhibition will select the chairs from the submissions.

ELIGIBILITY

This exhibition is open to owners and artists of chairs that can be considered unusually fun, funky, and functional. Chairs may be from any design period.

DELIVERY OF WORKS

All selected chairs must be delivered to HRAC by the listed deadline. HRAC reserves the right to disqualify any chairs which do not arrive by the stated deadline or are ready for professional display.

SHIPPING/DELIVERY

Shipping/delivery is the responsibility of the owner/artist. If a chair is shipped, a pre-paid return label must be included with the chair(s). Any artist/owner shipping chairs is responsible for insuring their chairs during shipment. HRAC is not responsible or liable for any damages occurring during shipping. While chairs are at HRAC, they will be insured for the declared value (sale price) only.

INSTALLATION

Chairs must arrive ready to be displayed. HRAC staff will be responsible for exhibition layout, lighting, and installation. In cases where chairs exceed basic installation owners/artists may be called upon to assist in installation. It is the responsibility of the owner/artist to communicate and provide any special installation needs, including: instructions, tools, equipment, etc.

AGREEMENT TO TERMS

Submission of chair(s) by an owner/artist indicates full agreement to the terms laid out in this prospectus. Any questions or concerns regarding this document must be discussed prior to submission. Upon successfully completing the submission process, owners/artists are expected to cooperate fully. Further agreements in the form of a completed and signed contract will be required for acceptance and display of the chair(s) to be finalized.
