This agreement is mutually accepted by _____ hereafter referred to as "**Buyer**", and by "**Dori Anderson, Agent for Breeder**", hereafter referred to as "**Breeder**".

This puppy/dog is a pure bred AKC registered AUSTRALIAN TERRIER: Gender: MALE FEMALE, Color: Blue/Tan, Red, or Sandy.

Buyer agrees to take puppy/dog age _____, to the Veterinary Doctor of choice to be assured puppy/dog is in good health, within 72 hours of purchase. The puppy/dog shots are current and complete as of this writing. Only Rabies shots need to be administered in compliance with State Law in which the puppy/dog will be residing. At the shot's one year of age, and every 3 years thereafter, a TiterChek test is **required** to assure that the immune system is in tact and all immunizations are stable Heartworm medication shall be administered year around to protect against heartworm, and in addition, whip, hook, and round worms. The Annual blood test is not required if puppy/dog is maintained on the year around protection. (UWM Veterinary School of Medicine documentation available to confirm.)

(XX)The following paragraph not applicable to companion dogs/puppies. () As show potential, This is a Co-Ownership Contract: Puppy/dog is registered with AKC, and at receipt of registration papers from AKC and full payment of **\$TBD.00**. Breeder will provide copies of the complete pedigree to Buyer and remain as owner/co-owner, as puppy/dog will be shown in conformation to Best of Breed American Kennel Club dog shows. Buyer acknowledges that he/she has knowledge of and understands the requirements and special care necessary (or is willing to learn) for show potential puppy/dog. Breeder agrees to train, groom, enter shows, and handle Puppy/Dog for regular fees, to the full championship. When puppy/dog reaches full Championship, and/or is retired from breeding, Breeder will sign-off ownership at such time proof of spay/neuter procedure is completed and documented by a Veterinarian **OR:**

(XX)As a companion, Breeder may/maynot provide registration papers and ownership, and a complete pedigree to Buyer after receipt of full payment of \$ TBD and, after proof that spay/neuter procedure has been completed: no sooner than 2 years of age for **females, with the Ovarian Sparing Spay or males, with Vasectomy** and documented by a Veterinarian. (Studies have shown that waiting until after 4 years of age using the Ovarian Sparing Spay or Vasectomy procedures protects the future health preventing many types of cancers and immune failures.)

(XX) The following paragraph not applicable to companion puppies or conformation puppies to be spayed/neutered following their championship.

() If Buyer and Breeder choose to breed Puppy, the potential mate must be an AKC registered AUSTRALIAN TERRIER, preferably an AKC Champion of record, and pedigree must be approved by Breeder prior to any breeding. The mate must have a complete physical to include testing for any possible sexually transmitted diseases, and genetic defects, including an OFA and Eye Cert.

(XXX) Training of Puppy must be gentle, persistent and consistent to be successful. Personality traits of AUSTRALIAN TERRIERS of this breeding are loving, soft, curious, and stubbornly persistent. Training must meet or exceed these traits without being harsh or abusive. Feeding schedules and starter food are provided as a courtesy. This puppy is warranted against genetic diseases up to five (5) years of age, provided diseases are not dietary and/or environmentally induced ie early spay/neuter, over immunizing and the health of the puppy/dog is properly maintained.

(X) If for any reason either party should decide the placement of Puppy/dog is failing to work favorably, Puppy/dog will be returned to **DORI ANDERSON**. When Puppy/dog is re-homed, any veterinary costs/foster costs will be **assigned to Buyer** listed in this contract.

(X) If Buyer chooses, Boarding Kennel Services may be provided for vacations or other such needs. Daily rates will be determined at the time the Services are rendered. Grooming and grooming training will be provided free for one full year and teaching new owner how to properly groom their new Australian Terrier. After one year, grooming services may be purchased at the current rates.

No other warranties or guaranties, expressed or implied, are made under this contract, except as stated above. **Failure to comply by Buyer will negate any and all health warranties.** Injuries or illnesses occurring at the hand of the Buyer will not be considered health issues covered under warranty.
