## TECHNICAL RIDER

### Dance Party Reunion: A Salute to Buddy Holly and Friends

- 01) AUDIO                   A. Front-of-House audio system appropriate for venue size: 16 discreet channels with 6 aux outputs.  
B. 6 discreet monitor sends with 6 low profile wedge monitors (2-way active x-over 12"/horn).  
C. Microphones, DIs and stands (see stage plot for line input requirements)
- 02) LIGHTING               A. Minimum 8 Freznel or Par 54 backlights, blue wash  
B. Minimum 8 Freznel or Par 54 frontlights, soft pink wash  
C. Minimum 8 Freznel or Par 54 sidelights, 4 per side (fills)  
D. 4 Key Lights (specials in front line) focused @ 45 degrees down  
E. 1 'follow-spot'  
D. 1 qualified lighting operator
- 03) STAGING               A. Minimum stage size of 40 feet wide by 30 feet deep  
B. Black backdrop measuring 12 feet in height, with wing curtains and cross  
C. One 6' (w) X 6' (L) X 12" (H) drum riser with carpet covering.  
G. Artist access from backstage  
H. 1 qualified stage manager
- 04) MISCELLANEOUS    A. NA
- 05) HOSPITALITY         A. Dressing rooms for 7 men, with hot and cold running water, toilet facilities, make-up mirror and comfortable seating affording privacy and direct access to the stage. Stocked with coffee and tea (caffeinated and decaffeinated). NO BOTTLED WATER PLEASE.
- 06) MERCHANDISING    A. NA
- 07) SOUND CHECK        A. Artists require ninety (90) minutes to adequately check the system. House must remain closed until sound check has been completed and Artists have left the stage. **3:30PM LOAD-IN, 5PM SOUND CHECK**
