**You are not allowed to practice with your dogs on the running grounds within 48 hours of the beginning of the event. Thank you.**

**ONLY COMPLETE ENTRY FORMS INCLUDING REGISTRATION NUMBERS** will be accepted.

**Bitches in season are eligible for entry in OAAB, but are not eligible for entry into any combined sex stake.**

**Returned checks do not constitute a valid entry fee.**
