NOTICE TO EXHIBITORS

AKC registered Dachshunds that are intact, spayed or neutered or have a Limited Registration may participate. Dachshunds with ILP or PAL numbers are not eligible for this competition.

Only dogs and bitches 6 months and older may compete.

You are not allowed to practice with your dogs on the running grounds within 48 hours of the beginning of the event. Thank you.

ONLY COMPLETE ENTRY FORMS INCLUDING REGISTRATION NUMBERS will be accepted.

Bitches in season are eligible for entry in OAAB, but are not eligible for entry into any combined sex stake.

Returned checks do not constitute a valid entry fee.

The Test Secretary shall add a \$25.00 collection fee to the amount of each returned check.
