- *Master Earthdog:** 30 feet, three 90-degree turns, with false entrance, den and exit,
identification of entrance, honor other working dog. Open to all
dogs that have completed a SE or ME title.

Notice to Exhibitors

Ribbons & Rosettes: Qualifiers in all classes will receive flat ribbons.

Those dogs earning titles will receive rosettes in place of flats.

Awards: GPDC medallion for qualifying Iron Dogs.

Bitches in season are not eligible for entry. Entry fees will not be refunded. Bitches in season must not be allowed to interfere with the running of the tests.

All dogs are to be held on short leash and under control while on the tests grounds. For everyone's safety, dogs shall NOT BE LEFT UNATTENDED in exercise pens while on the grounds.

Spectators may be allowed to view the test from an area predetermined by the TEST Judge, provided that they are quiet and do not distract the dogs. No dogs shall be allowed within 100 feet of the test areas.

Confirmed entrants not present at the testing area when their number is called will be moved to the end of the class except for ME class. In the ME class, any dog not present within 5 minutes after its brace is called will be marked absent by the judge. The remaining dog in that brace will be run as or with the by dog.

Returned checks do not constitute a valid entry fee. Fees must be reimbursed in guaranteed funds. Checks will not be accepted. The Earthdog Secretary will add a collection fee of \$25 to the amount of each returned check. Subsequent returned checks from the same exhibitor may result in their being put on a CASH ONLY basis. Any awards won by dogs with invalid entries because of NSF will be rescinded unless the club is reimbursed immediately.

Mollala/Oregon City

Follow OR-213 for about 3 miles

Turn left onto Beaver Creek Road, follow Beaver Creek Road about 3.7 miles

In downtown Beaver Creek, Beaver Creek Road makes a 90 degree left turn at a four way intersection. Make a left turn to stay onto Beaver Creek Road

Continue about 5 more miles on Beaver Creek Road

Turn right on S. Larkin Road

There will be a sign on the telephone pole beside the driveway for 24491. Turn right down the long driveway, just in front of the telephone pole with the sign. The driveway splits into 2 driveways. There is a gate to the right hand driveway and this is the neighbors. Please do not disrupt them.

The driveway eventually turns to the left. Parking will be at right angles to the driveway past that left turn, with overflow parking into 2 fields that will be marked.
