**Entry fees:** \$26.00 (includes AKC recording\* and service fee) for the first entry of a dog in each Obedience and/or Rally Trial, \$21.00 for the second entry of the same dog in the same Trial. Junior handler fees \$21 first entry and \$15 second entry of same dog.

\* "A RECORDING FEE of 50¢ is required for each dog entered at any licensed or Member Club Show, Obedience Trial, or Tracking Test. This recording fee is to be collected by the Show-giving Club and paid to the AKC. If a dog is entered in more than one class in the show, the recording fee is to be collected on the first entry only." (AKC Rule, Chapter 15, Section 2).

**Make all checks and money orders payable to:** Merrimac Dog Training Club, Inc. (MDTC, Inc.). Trial Secretary assumes no responsibility for cash sent through the mail.

**Entries without fees will not be accepted.** Acknowledgement of entries will be made as soon as practical. Should such acknowledgement not be received by the exhibitor within a reasonable time, please notify the Trial Secretary.

**Entries not on official AKC entry forms or photocopies of entry forms** without the agreement and rules on the reverse side of the official AKC entry form are not acceptable. Returned checks do not constitute a valid entry. A \$25.00 service fee will be added for all return checks.

**Express entries:** Please use "release signature" or the entry will be delayed.

**No entry** shall be made, and no entry shall be accepted which specifies any conditions as to its acceptance.

**Entry fees** shall not be refunded for bitches in season, or if a dog is absent, disqualified, excused by Veterinarian or Judge, or barred from competition by action of the Trial Committee. Extreme weather conditions, such as, but not limited to snow storms, hurricanes, lightning, extreme heat, must be considered for the health and safety of the dogs, exhibitors and spectators. The well-being of dogs, exhibitors and spectators is of paramount importance and, in the event, it is necessary to cancel or stop the show before completion, no refund of entry fee will be made.
