**Conditions of Contract:**

1. Upon return of this contract, mare owner must provide stallion owner with a copy of the mare’s Certificate of Registration.
2. The stallion breeding fee is \$1,600.00 – plus freight charges. Freight charges are at the cost of mare owner. All fees must be paid to Stallion owner before receiving semen.
3. Done N Dusted QH’s is not responsible for the untimely delivery or condition of the frozen semen, as we have no control of the shipment after it leaves our custody.
4. Each mare being bred with frozen semen will be allotted a total of two (2) doses of semen for the breeding season. One dose will be sent for the initial breed and if required a second dose will be sent at cost of freight paid by mare owner. After these 2 initial doses there will be a further charge of \$300.00 for each dose plus freight up to a further 2 more doses. The mare owner is only entitled to the amount of semen necessary to get their mare in foal; they do not own all four doses. Only one registerable foal will be allowed from this semen.
5. The semen will be stored at Beef Breeding Services Rockhampton. All communications will go through the stallion owner.
6. A LIVE FOAL GUARANTEE will apply for the next year’s breeding season only. (The term “live foal” means that the foal resulting from the breeding stands alone, nurses and lives for twenty-four (24) hours). The “live foal guarantee” will be void if mare owner does not notify the stallion agent within 48 hours after the time of foaling that the mare did not produce a live foal. To qualify for a rebreed the following year upon the death of a foal, a veterinary certificate is required to confirm that the foal died prior to the 24hr cutoff, and that the mare is in a fit state to be rebred. If the mare owner wishes to swap mares, a new contract must be completed but this contract will only be valid for the year of breeding.
7. Mare owner must send the insemination reports to Done N Dusted QH’s and must notify them of the mare’s pregnancy by 20 day scan and be shown via vet certificate.
8. Neither Done N Dusted QH’s (Heather Bowditch) nor any of its officers or employees shall be liable for damages as a result of damage to the semen or as a result of a mare failing to settle. Done N Dusted QH’s (Heather Bowditch) sole liability under this contract is a rebreed the following year if a live foal is not attained.
9. When the above named mare owner signs and returns this contract to Done N Dusted QH’s, it will then be a binding contract on both parties, subject to the above terms and conditions. This contract is not valid unless completed in full and may not be altered or amended, except by a written mutual consent of the parties herein.
10. The service must be used in the first breeding season and is only valid for rebreed for the next breeding season. The service will only last the initial first breeding season and next after that the contract is voided and service no longer available.
11. Donated or auctioned stallion services must be used in the breeding season purchased and rebreed the following season, after that the service is cancelled. On any donated stallion services a handling fee of \$165.00 GST Inclusive will apply and is payable to Done N Dusted QH’s before semen is shipped.
