DISCIPLINE STATEMENT

In accordance with State Law, our Discipline Guidelines are described below:

- (1) Child care facilities must ensure that age-appropriate, constructive disciplinary practices are used for children in care.
 - (a) Children shall not be subjected to discipline which is severe, humiliating or frightening.
 - (b) Discipline shall not be associated with food, rest or toileting.
 - (c) Spanking or any other form of physical punishment is prohibited.

- (2) Prior to admission of a child to a child care facility, the facility shall notify the parents in writing of the disciplinary practices used by the facility. Verification that child care facilities have provided parents in writing the disciplinary practices used by the facility shall be documented on the enrollment form or an equivalent form with the signature of the parent.
