Professional Services

Basic Services of Funeral Director and Staff.....\$ 2,500

Our fee for the Basic Services of Funeral Director and Staff includes, but is not limited to, Staff to respond to initial request for service; arrangement conference with family and responsible parties; arrangement of service/tribute; preparation and filing of necessary authorizations and permits; recording of Vital Statistics; preparation and placement of obituary notice; and coordination with those providing other portions of the funeral, e.g., cemetery, crematory, clergy, and others as required. Also included in this charge are overhead expenses relative to our facilities such as professional licensing, legal and accounting fees, insurance, building and utility expenses, parking lot and grounds maintenance, taxes, equipment, furnishings, inventory costs, record keeping, secretarial and administrative expenses.

This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving remains).

Minimum Administrative Fee.....\$ 500

We require the use of licensed personnel to supervise all technical aspects of our services. Utmost care is taken in all steps of our preparation. Our preparation facility is OSHA and State compliant. Our personnel and management take their role very seriously and it shows in the dedication to our client families.

Embalming.....\$ 650

Embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

Refrigeration.....\$ 300

It is the policy of our firm, in compliance with State law, to require refrigeration of an unembalmed body after 24 hours. This fee includes up to three days (72 hours) usage, thereafter it is \$25.00 per day.

Use of Facilities and Staff for Vigil, Funeral or Memorial Service.....\$ 595

Our services include: Setup and use of facilities for funeral service for up to four (4) hours, coordination of floral arrangements, supervision and attendance at funeral service by licensed and/or certified staff.

Use of Facilities and Staff for Funeral or Memorial Service followed by a Committal Service.....\$ 895

Our services include: Setup and use of facilities for funeral service for up to four (4) hours, coordination of floral arrangements, supervision and attendance at funeral service and committal service by licensed and/or certified staff.

Use of Staff and Equipment for Funeral or Memorial Service at another facility.....\$ 595

Our services include: Setup of facilities for funeral or memorial service, coordination of floral arrangements, supervision and attendance at funeral or memorial service by licensed and/or certified staff.

Use of Staff and Equipment for Funeral or Memorial Service at another facility followed by a Committal Service.....\$ 895

Our services include: Setup of facilities for funeral or memorial service, coordination of floral arrangements, supervision and attendance at funeral or memorial service and committal service by licensed and/or certified staff.

Use of Staff and Equipment for Graveside Service.....\$ 475

Our services include: Coordination of the floral arrangements, supervision and attendance at graveside service by licensed and/or certified staff, any necessary equipment.

Special Charges

Forwarding of Remains to another Funeral Home.....\$ 2,350

Our Charge includes: Transfer of deceased to funeral home, basic services of funeral director and staff, embalming, necessary authorizations, and local transportation to airport. This charge does not include merchandise, visitation, rites or ceremonies, or use of facilities prior to the forwarding of the remains.

- A. With minimum shipping container (combination unit).....\$ 2,600

(in addition to the cost of the casket and shipping air tray)

Receiving Remains from another Funeral Home.....\$ 1,950

Our Charge includes: Transfer of deceased to funeral home, basic services of funeral director and staff, embalming, necessary authorizations, and local transportation to airport. This charge does not include merchandise, visitation, rites or ceremonies, or use of facilities prior to the forwarding of the remains.

Immediate Burial.....\$ 2,725 to \$ 14,670

This charge includes: Transfer of deceased to the funeral home, refrigerated holding of remains, local transportation to cemetery, and basic services of funeral director and staff. This charge does not include the use of facilities and staff for any merchandise, visitation, rites or ceremonies, public or private, prior to or after burial.

- A. Immediate burial with casket provided by purchaser.....\$2,725
- B. Immediate burial with minimum casket from our funeral home.....\$4,320
- C. Immediate burial with casket selected from our funeral home.....\$2,725

Direct Cremation.....\$ 2,600 to \$ 11,595

This charge includes: Transfer of deceased to funeral home, refrigerated holding, necessary authorizations and basic services of staff, and transportation to local crematory. This charge does not include merchandise, the use of facilities and staff for any visitation, rites or ceremonies, public or private, prior to or after cremation, or any applicable crematory fees.

If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering).

The containers we provide are made of heavy fiberboard, heavy cardboard, or composition materials.
