### *Funeral Establishment Responsibility*

“Prior to drafting any contract for goods and services, the responsible party or the decedent’s survivor who is handling the funeral arrangement is entitled to receive a copy of any preneed agreement in the possession of the funeral establishment that has been signed and paid for, in full or in part, by or on the behalf of the decedent.”

The goods and services shown are those we can provide to our customers. You may choose only the items you desire; however, any funeral or cremation arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected. Where applicable, a sales tax of 8.75% will be added. Additional charges may apply for services conducted outside of our 30 mile radius or for services conducted evenings or weekends.

## PROFESSIONAL SERVICES

### **Basic Services of Funeral Director and Staff** **\$1,995**

Our fee for the basic services of funeral director and staff includes, but is not limited to, staff to respond to initial request for service; arrangement conference with family or responsible parties; arrangement of service/tribute; preparation and filing of necessary authorizations and permits; recording vital statistics; preparation and placement of obituary notice; and coordination with those providing other portions of the funeral (e.g. cemetery, crematory or others as required). Also included in this charge are overhead expenses relative to our facilities such as professional licensing, legal and accounting fees, insurance, building and utility expenses, parking lot and grounds, maintenance, taxes, equipment, furnishing, inventory costs, record keeping, secretarial and administrative expenses. *The fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving remains.)*

## FACILITIES, EQUIPMENT & STAFF

### **A. Daytime Visitation at the Funeral Home\* (Concludes before 5:00 p.m.)** **\$425** **Evening Visitation at the Funeral Home\* (Concludes after 5:00 p.m.)** **\$525** **Viewing one hour prior to services** **\$200**

Our services include: visitation set-up, use of visitation room for up to four hours, display of floral arrangements and supervision and attendance during the viewing, visitation or wake.

### **B. Funeral Service at the Funeral Home or Other Facility\*** **\$675**

Our services include: coordinating the funeral arrangements, supervision of funeral and staff to coordinate the funeral ceremony. This fee does not include church or other facility charges.

### **C. Memorial Service at the Funeral Home or Other Facility\*** **\$675**

Our services include: coordinating the memorial service, supervision of the memorial service, staff to attend the memorial service, set-up and use of facilities for memorial service. This fee does not include church or other facility charges.

### **D. Graveside Service\*** **\$675**

Our services include: coordinating the funeral arrangements at graveside, supervision of the graveside service, equipment and staff necessary to set-up the graveside service.

### **\* Additional Charge for Weekend Service** **\$250**

### **E. Committal Service** **\$195**

Following a funeral service only. Our services include: coordinating of the funeral arrangements at graveside, supervision of the graveside service, equipment and staff necessary to set up the committal service.

### **F. Use of Reception Room** **\$395**

Three hour rental or fraction thereof, includes coffee service for 50 people.

### **G. Chapel Rental & Staff of Higgins Chapel** **\$950**

**Only** for families who have used other funeral facilities. Our services include: setup and use of facilities for memorial service, a proportionate share of overhead expenses, supervision and attendance at service by licensed staff.

### **H. Private Family Experience** **\$200**

Half hour visitation for family only (up to 10 people).

## PREPARATION

We require the use of licensed personnel to supervise all technical aspects of our services. Utmost care is taken in all steps of our preparation and our preparation facility is OSHA and State compliant.

### **Embalming** **\$595**

Embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

### **Forwarding Remains to Another Funeral Home** **\$2,395**

This charge includes: Basic services of staff, transfer of deceased to the funeral home, embalming as necessary, obtaining necessary authorizations and local transportation via service vehicle to airport. This charge does not include visitation, rites or other ceremonies and does not include airline fees.

### **Receiving Remains from Another Funeral Home** **\$1,895**

This charge includes: Basic services of staff, transfer of deceased to funeral home, and transportation of deceased to cemetery via service vehicle. This charge does not include visitation, rites or ceremonies.

### **Immediate Burial** **\$1,995 to \$13,490**

This charge includes: Basic services of staff, transfer of deceased to funeral home, refrigerated holding, local transportation via service vehicle to the cemetery, obtaining necessary authorizations and basic service of staff. This charge does not include the use of facilities and staff, for public or private visitation, ceremony or graveside service.

### **Direct Cremation** **\$2,530.50 to \$7,540**

This charge for a direct cremation includes: transfer of deceased to our funeral home, local transportation to the crematory, refrigerated holding, obtaining necessary authorizations and basic services of the staff and the crematory fee. This charge does not include merchandise, use of facilities and staff for any public or private visitation or ceremony.

Alternative containers may be used for direct cremations. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we provide are made of heavy fiberboard or composition materials.
