Professional Services

Basic Services of Funeral Director and Staff **\$2,500.00**

Our fee for Basic Services of Funeral Director and Staff includes, but is not limited to, Staff to respond to initial request for services, arrangement conference with family and responsible parties, arrangement of service/life celebration, preparation and filing of necessary authorizations and permits, recording of Vital Statistics, preparation and placement of obituary notice, and coordination with those providing other portions of the funeral (cemetery, crematory, clergy, and others as required). Also included in this charge are overhead expenses relative to our facilities, such as professional licensing, legal and accounting fees, insurance, building and utility expenses, grounds maintenance, taxes, equipment, furnishings, inventory costs, record keeping, secretarial and administrative expenses.

The charge for our Basic Service Fee will be added to the total cost of the funeral arrangements you select and is non-declinable. (this fee is already included in our charges for direct cremation, immediate burial and forwarding/receiving of remains.)

Minimum Administrative Fee **\$500.00**

Embalming **\$ 650.00**

Except in certain special cases, embalming is not required by law. Embalming may be necessary; however, if you select certain funeral arrangements, such as a funeral with viewing, if you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial. Embalming of the remains is required if a family chooses to hold an open casket visitation or service.
