Interrelationship of building and surroundings: This site is associated with the writer, actor, singer, and civil rights activist Paul Robeson, who lived here in the mid-20th century.

The property is a 1.58-acre lot on the east side of Enfield Street in the Enfield Historic District. The house is set back from the street behind a deep lawn and curving driveway with scattered shade trees.

Other notable features of building or site: The house is a 2 1/2-story Neo-classical Revival-style building with a five-bay facade facing west, including a full-height projecting gable-roofed portico with a monumental colonnade of four full-height columns. A perpendicular wing extends east. The walls visible from the street are finished in stucco with wood trim forming the classical portico and eave details.

Historical or Architectural importance:

The house is a contributing resource in the Enfield Historic District, which includes the buildings lining Enfield Street, the main street of the town, located on a north-south trending hilltop east of and parallel to the Connecticut River. The date of this house is given as 1850 in the historic district nomination, though it appears possible that its detailing may date from an early-20th-century updating.

The house was the home of Paul and Eslanda Robeson from 1940-1953. Their son Paul Robeson, Jr (1927-2014), grew up here and graduated from Enfield High School. The Robesons were forced to sell the house for financial reasons during the period of Paul Robeson's blacklisting and confiscation of his passport, which prevented him from traveling to perform outside the United States.

Paul Robeson (1898-1976) was an All-American football player, a Phi Beta Kappa scholarship student at Rutgers University and a graduate of the Columbia University Law School. An African American, he later became an internationally known actor and singer. He was an activist in civil rights causes. Robeson purchased this Enfield house during the height of his popularity and used it to entertain his guests. His family owned it from March 1940 until December 1953.

Robeson's refusal to remain silent about racism in the United States, along with his active desire for full human justice and his Socialist views, resulted in his being ostracized by American society and persecuted by the forces of anti-Communism in the post-World War II years. He was barred from appearing at concert halls, had his passport revoked and saw his name removed from the football records he had established. He spent the last 15 years of his life in exile abroad and as a recluse in Philadelphia, dying in January 1976. In 1995, Robeson was posthumously inducted into the National Football Foundation's College Football Hall of Fame.
