**SENIOR CAPITAL PLAYER PRIVILEGES**

Upon execution of this Senior Capital Player Agreement (“Agreement”), and payment of the non-refundable **\$200.00** Prepaid Senior Capital Player Fee, plus any applicable taxes, Player will receive a Senior Capital Player’s Card allowing Senior Player the access to the Senior Capital Player Privileges, set forth herein below, until **December 31, 2021**. Upon the expiration of this Agreement, Senior Player may not access the Club unless Senior Player completes a new Agreement or acquires a membership at the Club.

Club and Senior Player agree and acknowledge that Senior Player may enjoy the following privileges at the Club during 2020 and subject to the terms and conditions stated herein (the “Senior Capital Player Privileges”):

- Prior to December 31, 2021, one (1) cart-fee only round of golf to be used Monday – Friday or after 12:00 p.m. on a Saturday or Sunday. Any unused rounds will be automatically forfeited on December 31, 2021. Such rounds are non-transferable, may not be redeemed for cash and may not be relocated to any affiliate club.
- Senior Players may reserve tee times up to 14 days in advance.
- One (1) small bucket of range balls with the purchase of an 18-hole round of golf.
- 10% discount on select golf shop merchandise.
- Range and practice facility usage at the Club’s range facilities during regular operating hours, subject to availability, in exchange for an additional **\$200.00** prepaid annual fee.
- Access to the golf course during regular operating hours in exchange for the following applicable pay-per-use green fees. Applicable sales tax, if any, not included. Pay-per-use green fees are subject customary increases at the Club’s sole and absolute discretion. Senior Player understands and agrees that regardless of Senior Player’s use of the Club’s facilities and amenities, pay-per-use green fees are nonrefundable, do not have any stored or cash value, and may not be transferred or relocated to any affiliate club

The Senior Player Privileges are personal to Senior Player and do not include access for Senior Player’s guests, unauthorized spouse or dependents, who must pay the applicable fees in order to access the Club’s facilities. Senior Capital Player Fees are subject to customary increases and late fee/collection penalties. Senior Player will not have account charging privileges at the Club and agrees to pay all applicable fees and charges at the point of sale. The Club reserves the right to restrict access to the golf facilities for maintenance, repairs, weather, special events and golf outings during the weekdays and on weekends as it deems necessary from time to time, and the foregoing will not result in any reduction, abatement or refund of applicable fees or charges.

Senior Capital Player Privileges are contingent on successful completion of the Club’s enrollment process. If accepted as a Senior Player, I agree to conform to and be bound by the Club’s Rules and Regulations and other written or posted policies, and

acknowledge that such agreement is an integral part of my agreement for privileges at the Club. I also acknowledge I have received, read and understand the Club's Rules and Regulations.

I ASSUME ALL RISKS associated with accessing the Club facilities and the facilities of any participating network clubs, including, but not limited to, dining and event rooms, recreational amenities and outdoor areas, grounds, parking areas, equipment, golf balls or clubs, and golf carts. I ALSO HEREBY FULLY RELEASE AND DISCHARGE THE CLUB, ITS PARENT, AFFILIATED AND SUCCESSOR COMPANIES, AND ALL OF THEIR RESPECTIVE EMPLOYEES, AGENTS, SHAREHOLDERS, MEMBERS, MANAGERS, AFFILIATES AND ASSIGNS (THE "RELEASED PARTIES") FROM ANY AND ALL LIABILITIES, INJURIES, LOSSES, DAMAGES OR CLAIMS ARISING FROM MY OR MY FAMILY'S USE OF THE CLUB FACILITIES, INCLUDING ANY SUCH CLAIMS CAUSED BY THE RELEASED PARTY'S OWN NEGLIGENCE. In its sole and absolute discretion, the Club may redeem my membership at any time by paying me a pro-rated portion of the annual dues for the remainder of the membership year (without interest or premium of any kind), if any, that I paid to the Club. Upon such redemption, all of my rights to use the Club will immediately cease, and I shall automatically RELINQUISH, RELEASE AND DISCHARGE THE RELEASED PARTIES FROM ANY AND ALL LIABILITIES, INJURIES, LOSSES, DAMAGES OR CLAIMS ASSOCIATED WITH MY MEMBERSHIP AND THE REDEMPTION THEREOF.

By providing my contact information above, I give the Club my express written permission to contact me in accordance with the terms and conditions of the Club's *Privacy Policy*, a copy of which is available on the Club's website. I can revoke this consent at any time by contacting the Club in writing. I also agree to the terms of the *Privacy Policy*. I give the Club a non-exclusive license to use my or my family's name, quoted statements, photograph and likeness in Club publications or on the Club's premises for marketing or promotional purposes.

If accepted into Senior Capital Player Privileges at the Club, this Agreement, any promissory note or addendum hereto, and the Club's Rules and Regulations will be my membership contract with the Club. The terms and conditions of my membership may not be added to, amended or contradicted in any way by evidence of prior, contemporaneous or subsequent oral agreements of any kind, and I acknowledge there are no unwritten agreements of any kind. By submitting this Agreement, I represent and affirm that the information provided herein is true and correct. If signing electronically, I agree that my electronic signature has the full force and effect of a signature affixed by hand to a paper document.
