Membership

Membership is open to all families of the CTJ, Tejeda, and Hill programs. Family Membership is \$25.00 per family per year for general membership – each family membership is entitled to a single vote

Family Membership will be tiered

- Bronze \$100
- Silver \$250
- Gold \$500
- Platinum \$1,000 or more

Corporate Membership will be tiered

- Bronze \$500 per year (goods/services)
- Silver \$1,000 per year (goods/services)
- Gold \$2,500 per year (goods/services)
- Platinum \$5,000 per year (goods/services)

Membership will run from June 1st to May 31st the following year regardless of the date of joining the organization – Family Membership has single vote. Corporate membership does not have voting rights.
